GENERAL PRICE LIST

General Information/Disclosures: Prices are effective October 31, 2025, and are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing in the statement we provide describing the funeral goods and services you selected.

The list does not include prices for certain items that you may ask us to buy for you such as cemetery or crematory services, flowers, and newspaper notices. The prices for these items will be shown on your bill or the statement describing the funeral goods and services you selected. We do not charge you for our services in buying these items. Certain funeral services may be provided off-premises by other funeral service providers.

Basic Services of Funeral Director and Staff - \$2790

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select (this fee is already included in our charges for direct cremation, simple cremation, immediate burials, forwarding and receiving remains).

This charge includes, but is not limited to, arrangement conference; coordination of cemetery and/or crematory for final disposition of the deceased; procurement, preparation, and filing of necessary notices; general administrative and record keeping expense; and general overhead expense such as maintenance, equipment, inventory and insurance costs, and governmental compliance.

Embalming

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it (such as direct cremation or immediate burial).

Embalming of normal remains - \$950

Embalming of autopsied remains, add \$275

Embalming of organ-donor remains, add \$350

Other Preparation of Remains

Cosmetology, dressing, casketing* - **\$320**

**a surcharge of \$100 may be added for remains over 300 pounds*

Minor restoration of remains (if requested) - **No charge**

Reconstructive Restoration, when necessary (*per hour, not to exceed \$500*) - **\$95**

Professional Hairdresser – **see in Cash Advance Section of General Price List**

Refrigeration of remains (beyond 24 hours, per day) - **\$50**

Sanitary Care* - **\$380**

**When there is no embalming and in the event of delayed disposition, this will include minimal topical disinfection, dressing and encasement of the unembalmed remains, a waterproof pouch as required by the State of New Hampshire, and up to 48 hours of storage prior to burial, cremation, or other disposition. This also includes the care and disposal of regulated medical waste.*

Use of facilities and staff for viewing - \$695

Includes a two-hour public visitation time at Jellison Funeral Home, with a private family viewing (limited to immediate family only in attendance for a period of thirty (30) minutes prior to the start of a scheduled visitation). A charge of \$200 per hour will apply to public visitations lasting longer than two hours. Includes a tribute video.

Off-premises visitation (includes equipment and staff) - \$695

Use of facilities and staff for funeral ceremony - \$595

Includes on premise funeral ceremonies held at Jellison Funeral Home and off premise funeral ceremonies held at any church, hall, or fraternal organization.

Use of facilities and staff for memorial service - \$595

Includes on premise memorial services held at Jellison Funeral Home and off premise memorial services held at any church, hall, or fraternal organization.

Use of equipment and staff for graveside services* - \$595

**For Springtime Internments made necessary by seasonal cemetery closures: Scheduling is limited to Monday through Thursday, from 10:00 AM to 1:00 PM. There will be a \$250.00 surcharge for internments held during other times.*

Private Family Viewing - \$295

Limited to 10 persons in attendance for a period of 1 hour weekdays 10am – 2pm. No published announcements and no ceremonies are included. Additional time or attendance will result in full visitation charge.

Transfer of remains to funeral home - \$395

This charge includes all necessary equipment and personnel for the transfer of the deceased from place of death to Jellison Funeral Home. A surcharge of \$100 will be added for remains over 300 pounds.

*There will be a charge of \$795 for transfer of remains from a residence to our funeral home when another funeral home refuses, or is otherwise unavailable, to transfer from place of death and care is returned to the refusing funeral home. (Particularly Keene area and Hillsborough area)

Transfer of remains to final disposition (to crematory, airport, or medical examiner) - \$295

Hearse (used for funeral) - \$395

Limousine - Available as desired at the prevailing rate of the rental company.

Service Vehicle* - \$195

*Used for any of the following: To secure necessary certificates, permits, physicians' authorizations and/or to transport equipment, flowers and pallbearers or escorting the funeral procession.

All transportation charges are for local service.
Beyond 20 miles, add \$2.90 per loaded mile, per vehicle.

Immediate Burial and Green Burial - \$3985 to \$6890

This charge includes a discounted rate of Jellison Funeral Home's basic services of funeral director and staff, removal of remains from within our local service area, dressing and casketing, sanitary care, hearse, service car and transportation to/coordination with the cemetery.

This charge does not include obituaries, certified copies of the death certificate, cash advances (including grave opening charges), outer burial container, or any additional merchandise or the use of facilities and staff for any visitation or ceremony, public or private, prior to or after the burial.

Immediate burial with casket provided by the purchaser - \$3985

Immediate burial with minimum container provided by the funeral home - \$4110*

*Cost includes the alternative container provided at Jellison Funeral Home - \$125

Immediate burial with casket as selected - \$3985*

*Plus the cost of casket selected. A complete price list of caskets is provided at the funeral home; Casket prices range from \$795 to \$2905.

Cremation Options

Direct Cremation - \$2575 to \$5215

Our charge for direct cremation includes: discounted basic services of the funeral director and staff; removal of remains from within our local service area, sanitary care, service vehicle, transportation to the crematory and necessary authorizations/filing of NH Death Certificate.

If you choose to arrange a direct cremation, you can use an alternative container provided by the funeral home. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are unfinished boxes made of particleboard, pine, and cardboard.

Direct cremation with container provided by the purchaser - \$2575

Direct cremation with alternative container - \$2700*

*Cost includes the alternative container provided at Jellison Funeral Home - \$125

Direct cremation with cremation casket as selected - \$2575*

*Plus the cost of casket selected; a complete price list of caskets is provided at the funeral home. Cremation caskets range from \$795 to \$2640.

Our charge for direct cremation does not include any cash advance payments, including obituaries, certified copies of the death certificate, crematory fees, or any additional merchandise. It does not include services of the funeral home for obtaining certified copies of the death certificate and delivery of same, coordination and placement of obituaries in newspapers, or coordination with cemeteries. It also does not include use of facilities and staff for any visitation or ceremony, public or private, prior to or after the cremation. Cremated remains are required to be picked up at the funeral home within one week of cremation taking place.

Simple Cremation – \$3590 to \$6230

Our charge for simple cremation includes: discounted basic services of the funeral director and staff; removal of remains from within our local service area, sanitary care, service vehicle, transportation to the crematory and necessary authorizations/filing of NH Death Certificate, obtaining and providing to family certified copies of death certificates, delivery of cremated remains in local service area, coordination and placement of obituaries, coordination with cemetery chosen for final disposition (if any).

If you choose to arrange a simple cremation, you can use an alternative container provided by the funeral home. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are unfinished boxes made of particleboard, pine, and cardboard.

Simple cremation with container provided by the purchaser - \$3590

Simple cremation with alternative container - \$3715*

*Cost includes the alternative container provided at Jellison Funeral Home - \$125

Simple cremation with cremation casket as selected - \$3590*

*Plus the cost of casket selected; a complete price list of caskets is provided at the funeral home.

Cremation caskets range from \$795 to \$2640.

Our charge for simple cremation does not include any cash advance payments, including obituaries, certified copies of the death certificate, crematory fees, cemetery fees, or any additional merchandise. It also does not include use of facilities and staff for any visitation or ceremony, public or private, prior to or after the cremation.

Additional Cremation Services: Additional cremation services, such as those with visitation/viewing, memorial service, or graveside service at the cemetery, will be itemized per the General Price List.

Witnessed Cremation - \$250

Our charge includes the coordination and subsequent management of the Witnessed Cremation with our crematory partner, Michaud Crematorium. Scheduling is limited to Monday through Friday, from 9AM-1PM. Witnessed Cremation is limited to 5 persons of immediate family only in attendance for a period of thirty (30) minutes in entirety at the crematory. This service is based strictly on the availability of both Jellison Funeral Home, and the crematory. Once scheduled, you may choose to travel in procession with the hearse, or to meet the funeral director and staff directly at the crematory for the scheduled time.

Storage of the Cremated Remains

Cremated remains may be held at the funeral home at no charge for thirty (30) days until arrangements are made for proper release to the family or responsible party at our facility during our regular business hours. After thirty (30) days a \$25 fee will be assessed per month, or any portion thereof, for shelter and storage of the cremated remains. After ninety (90) Days, cremated remains left at the funeral home will be considered as unclaimed and/or abandoned and the Jellison Funeral Home & Cremation Service will respectfully dispose of them according to NH RSA 325-A:27.

Anatomical Donation to a Medical School - \$ 2,195.00*

*Medical Schools will typically compensate us for a portion of the removal and transfer of remains to the appropriate location. This fee includes the removal of remains and transfer only. All other services will be subject to pricing from the General Price List.

Please note: Many Anatomical Donations are rejected at the time of death for various reasons by the medical schools. It is always wise to be prepared with alternate plans for final disposition in case rejection occurs.

Forwarding Remains to Another Funeral Home: \$4810

This charge includes discounted/limited basic services of the Funeral Director and Staff, removal of remains within our service area, embalming, dressing and casketing of remains, service vehicle for necessary permits and certificates, transportation to Manchester airport.

This charge does not include the use of facilities and staff for any visitation or ceremonies, public or private, prior to or after forwarding of the remains. If the remains are to be transported to another funeral home outside of our service area or an airport other than Manchester, NH by automobile, additional mileage fees will be determined by location and distance. This price also does not include the airfare charges incurred for air shipment of the remains. An exact price will be provided to you prior to the service being provided.

With minimum airline approved shipping container (\$275): \$5085

With casket selected from our funeral home or another source: \$4810*

*Plus the cost of casket selected

Receiving Remains from Another Funeral Home - \$3535

This charge includes basic services of funeral director and staff, and transportation of remains to the cemetery or crematory.

This charge does not include additional remains preparation, the use of facilities and staff for any visitation or ceremony, public or private, prior to or after the burial/cremation. This charge does not include any additional cash advance charges such as cemetery opening, vault charges, crematory charges etc. Additional charges for Custodial Care and Storage of remains may also apply. If the funeral home is asked to provide additional services, costs will be itemized per the GPL.

Receiving Cremated Remains

Receiving cremated remains charge includes receiving of cremated remains, and local transportation to the cemetery. This charge does not include the use of facilities and staff for any visitation, rites, or ceremony, public or private, prior to or after the burial. This charge also does not include cemetery opening fees or clergy fees.

With complete graveside committal service and family in attendance - \$1,295

(Additional \$250 for weekends and allowed holidays)

Interment at our convenience and no one in attendance - \$ 375

CASH ADVANCE PRICE LIST

These prices are estimates as of October 31, 2025 and are subject to change without notice. The items shown below are Cash Advances. These are fees that we are able to pay on your behalf and then include in our statement. We do not charge you for this service. Cash advances are outside services which must be retained in order for many arrangements to be completed as requested. Since these prices are set by third parties, the prices on this list are subject to change without notice. The exact fees will be provided to you at the time of service. These items must be paid for in advance and include, but are not limited to:

Grave Opening Charges..... \$150 to \$ 2850

These rates vary according to which cemetery is selected, if it is a cremation urn or a casket burial, and if the cemetery has different rates for summer and winter burials, or weekend and holiday overtime charges.

Crematorium Fee \$425*

*Includes State of New Hampshire Medical Examiner Fee of \$60

Church Fees:

Clergy Honorariums..... \$200 to \$450

Organist Charges..... \$200 to \$300

Vocalist Charges..... \$200 to \$250

Sexton Charges..... \$100 to \$200

Parish Hall Fees..... \$100 to \$400

These are general rates. Each fee varies according to which church is used.

Professional Hairdresser: \$150

Obituaries

Prices vary *widely* between newspaper publications. Generally, obituary rates depend upon the paper selected, the length of obituary, how many days it is to run, etc. These prices can range from \$250 to more than \$1000. We are happy to get a quote for you.

NH Certified Copies of the Death Certificate.....\$15 first copy/\$10 add'l copies

These rates apply each time we request certified copies for you. Out of state death certificate charges will be different.

Air Transportation Charges.....Varied

Out of Town Funeral Director charges and Burial Permit fees..... Varied

These rates vary according to what services are utilized from the other Funeral Director and where the death occurs.

Grave Marker Inscription..... Varied

These rates vary according to which monument company is selected and how much information needs to be cut into the marker. Generally, the minimum amount is \$ 150.

Other Cemetery Fees* (*Use of Artificial Grave Grass, Lowering Devices, Cemetery Tents*)Varied

*These fees are considered cash advance items, and they are set by the vault companies for the rental and use of these items. Fees may differ for services in out of state cemeteries. Examples include, but are not limited to:

Associated Cash Advances from Vault Companies

- Artificial Grass and Lowering Device Use - \$180
- Tent and Chairs with Vault - \$380
- Cemetery Tent without a vault - \$360
- Chairs - No charge for the first 6, \$30 for an additional 6 chairs
- Above Ground Sealer Vault - \$400
- Saturday Charges - extra \$300
- Sunday Charges - extra \$400
- Holiday Charges - extra \$450

General Policies

We endeavor to provide you with appropriate services and ceremonies to meet your needs in celebrating the life of your loved one. It is important that the arrangements meet your wishes and budget. Please review the following policies of our funeral home.

Embalming: Embalming is not required by law. However, should you choose to have a public viewing, embalming will be required with our funeral home.

Viewing: All viewings (even with embalming) will take place within 7 days of the date of death.

Private family viewing: Must occur within 48 hours from time of death when embalming is not selected. We regret that this cannot be offered when trauma or decomposition is present, after an autopsy, or when organ donation has occurred.

Spring interments/full burial: All full burial interments will be completed by May 31st of each year.

Spring interments/cremated remains: Spring interments should be scheduled as soon as possible once cemeteries are open. Spring interments are scheduled Mon-Thurs during regular business hours. Interment requests outside these times will be considered with the additional fee of \$250 (noted in GPL) and based on availability of the funeral home.

Third-party merchandise: We welcome third-party merchandise of all kinds. Please note that we are not responsible for the quality of the merchandise brought into the funeral home and cannot be held accountable for breakage or defects that occur in the normal process of handling remains. Example: cremation jewelry that breaks during the process of filling it or won't seal properly.

Payment Policy: In an effort to provide the finest services possible, we are dependent upon the families we serve for making payment in a timely fashion. Payment is due within 10 days of date of death, except for full burials. Due to the significant expense that the funeral home must pay in advance, payment for full burial services is required before the date of burial. For your convenience, we offer as many simple payment options as possible: Personal Check, Bank Check, Money Order, Cash, Visa, MasterCard, Debit Card. A 3.5% charge will be added to credit card payments.

Assignable Life Insurance: Life insurance may be used as a means of full or partial payment for funeral and other related expenses. (Must be verified in advance) We can assist the family with processing the various claims forms.

We regret that we are unable to accept settlement of estates through attorneys or probate court as a means of financial arrangements. The family is responsible for the entire balance according to our payment policy. The family will be eligible for complete reimbursement from the estate. Should payment be made by an estate or insurance company (not including life insurance discussed during the arrangement) any compassionate discount provided will be rescinded and the full amount of the statement will be billed.

We also regret that we are unable to accept private or 'in-house' payment plans as a means of financial arrangements.

All unpaid balances after thirty days (30) from the date of death accrue late fee charges of 1.5% per month (18% per year). All late fees are incurred from the date of death. All unpaid balances after ninety days (90) from the date of death may be submitted to an agency for collection.
