CHATS Day Program is a full-day community-based program, offering respite to caregivers and providing older adults and persons with age related conditions with individualized plans of care. The program includes a variety of social and wellness activities, companionship, nutritious snacks, and lunch, in a safe, friendly, and caring environment while addressing social isolation for older adults. Activities include exercise, mental stimulation, crafts, relaxation programs, entertainment, health promotion, and disease prevention. Programs are also being offered virtually.

Reporting to the Day Program Manager, you will manage the overall day to day coordination of a Day Program. You will be responsible for the supervision of staff, students and volunteers and the safe delivery of a quality therapeutic program to clients.

Responsibilities include leading the delivery of Adult Day program services within a multi-disciplinary team and an integrated wellness model; coordination of client needs assessment using inter-RAI-CHA, staff supervision, liaison with Home and Community Care Support Services (HCCSS) to support care planning and meeting performance targets. You must be willing to work On-Call on a Saturday, on a 7-week rotation.

We'd like you to become part of our team if you have a degree or diploma in Recreation, Gerontology or a related field, experience within a hospital, LTC or community health setting. You have a minimum of three (3) years' supervisory experience in community health setting. You have demonstrated success in implementing and evaluating services and programs and have the ability to work in a multi-disciplinary team. Experience in day program coordination and case management preferred. You have excellent verbal, written and communication skills. You are creative in problem-solving and thoroughly enjoy working with seniors who have complex care needs. You must have a valid CPR and First Aid certificate. Proficiency in both official languages (English and French) an asset.
