The Pavilion is available for approved private rentals, subject to event size, required time, service requirements, and operational impact. All rental windows include setup, guest arrival, event time, breakdown, cleanup, and removal of personal items, decor, rentals, and vendor materials.

Package Details

*Family Celebration Package - Members Only

Designed for small kids' birthday parties, family celebrations, team gatherings, and casual member-hosted events of 25 guests or fewer.

- 4-hour total reservation window
- \$500 rental fee
- \$150 cleaning fee
- \$300 Canyon Grille food and beverage minimum (\$12/person)
- \$500 refundable deposit or credit card hold
- \$250/hour overage fee

Marina Gathering

Best for milestone birthdays, rehearsal-style gatherings, resident club events, corporate receptions, and elevated private events of up to 75 guests.

- 6-hour total reservation window
- \$1,500 member rental fee / \$3,500 non-resident rental fee
- \$250 cleaning fee
- \$1,500 Canyon Grille food and beverage minimum (\$20/person)
- \$1,000 member deposit or credit card hold / \$1,500 non-resident deposit or credit card hold
- Event Monitor required at \$30/hour for the full reservation window
- \$350/hour overage fee



Private Pavilion Event

Best for larger celebrations, private receptions, weddings contained to the Pavilion area, and events requiring more coordination or vendor support.

- 8-hour total reservation window
- \$2,500 member rental fee / \$4,500 non-resident rental fee
- \$350 cleaning fee
- \$3,000 Canyon Grille food and beverage minimum (\$20/person)
- \$2,500 member deposit or credit card hold / \$4,500 non-resident deposit or credit card hold
- Event Monitor required at \$30/hour for the full reservation window
- \$350/hour overage fee

Premier Pavilion Experience

Best for full-scale private events, premium celebrations, high-impact events, expanded service needs, or events exceeding standard time, guest count, or operational scope.

- Pricing, cleaning, staffing, patrol, deposit, food and beverage minimum, and Event Monitor requirements are custom based on event scope
- Event Monitor required at \$30/hour or custom staffing rate, depending on event scope and staffing plan

Important Rental Policies

Event Monitor Requirement

An RHYC Event Monitor is required for all Pavilion rentals except the Members-only Family Celebration Package. The Event Monitor helps protect the Pavilion, support event flow, monitor approved use of the space, and ensure the event remains within the agreed rental terms.

The Event Monitor fee is \$30 per hour and is billed for the full reservation window, including setup, guest arrival, event time, breakdown, cleanup, and vendor load-out. If an event exceeds the approved reservation window, additional Event Monitor time will be billed at \$30 per hour in addition to applicable overage or tier escalation charges.

Valet Services

Valet services may be required based on the type of event, anticipated guest count, parking needs, and overall impact to member access and club operations. RHYC management will determine whether valet service is required during the event review and approval process.

Valet service pricing starts at \$200 per hour for one valet host. Additional valet hosts may be required depending on the number of attendees, event timing, and parking demand. Final valet requirements and costs will be confirmed prior to event approval.

Overtime / Extended Use Policy

- All rental packages include a designated reservation window. This window includes setup, guest arrival, event time, breakdown, cleanup, and removal of all personal items, decor, rentals, and vendor materials.
- Events that exceed the approved reservation window will be billed at the applicable hourly overage rate for the selected tier. Overage is billed in full-hour increments, regardless of whether the full hour is used.

- If an event exceeds the approved time, guest count, setup needs, staffing requirements, food and beverage scope, cleanup expectations, or reserved Pavilion area, RHYC reserves the right to reclassify the event into the next applicable rental tier and bill accordingly.
- Additional time is not guaranteed and must be approved by RHYC management. Unauthorized overtime may result in additional charges, deposit deductions, and/or restrictions on future rentals.
- All music must cease at 9:00 pm due to Lakeway City Ordinance.

Outside Food and Beverage Policy

Outside Food / Alcohol Policy

Requests for outside food must be submitted in advance and receive prior written approval from RHYC management.

Outside food may be allowed once the required Canyon Grille food and beverage minimum has been met and/or if Canyon Grille cannot meet the needs of the party menu.

Outside alcohol is never permitted, and the event may be shut down if outside alcohol is found onsite.

Wedding and Ceremony Use

- Weddings and ceremonies may be permitted for an additional fee and at management discretion at certain times of the year and when the event is fully contained to the Pavilion area and approved in advance by RHYC management.
- The wedding party must get dressed and ready off-site. RHYC does not provide dressing rooms, bridal suites, staging rooms, or private preparation areas as part of the Pavilion rental.
- Ceremony seating, decor, floral, photography, music, vendor access, and guest flow must remain within the approved Pavilion rental area unless otherwise approved in writing.
- Additional vendor, time, staffing, or setup needs may require tier escalation or custom pricing.

Deposits and Credit Card Holds

- A refundable deposit or credit card hold is required to secure the reservation.
- Deposits or card holds may be used for damages, excessive cleanup, missing items, unapproved overtime, outside alcohol violations, or failure to follow rental policies.
- Non-resident rentals require a larger deposit or credit card hold due to the increased access and operational oversight required for private club use.
