These prices are effective as of December 15, 2025 and are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

SERVICES OF FUNERAL HOME STAFF, FACILITIES AND EQUIPMENT

- A. Basic Services of Funeral Directors and Staff** **\$2495**
- ◆ This fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral, e.g. cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utilities expenses, parking lot and grounds, maintenance, taxes, equipment, furnishing, inventory costs, record-keeping, and secretarial and administrative expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)
- B. Services, Facilities, and Staff for Funeral Ceremony at Funeral Home or Other Facility**
- Monday through Friday (8:00 a.m. to 4:00 p.m.)** **\$700**
- Saturday and Sunday or weekday after 5:00 p.m.** **\$995**
- ◆ Services include coordinating funeral arrangements, supervision of the funeral, staff to attend the funeral ceremony, setup, use of facilities for funeral ceremony, equipment and additional staff necessary to conduct a funeral at another facility.
- C. Services for a Graveside** **\$250**
- ◆ Staff member to supervise and coordinate final disposition.
- D. Services and Facilities for One Day Visitation at Funeral Home or Other Facility** **\$525**
- ◆ Use of the visitation room and receiving family and friends; display of floral arrangements; supervision and attendance during visitation; parking facilities, utilities, extra housekeeping.
- E. Services, Facilities, and Staff for a Memorial Service at the Funeral Home or Other Facility**
- Monday through Friday (8:00 a.m. to 4:00 p.m.)** **\$700**
- Saturday and Sunday or weekday after 5:00 p.m.** **\$995**
- ◆ Our services include coordinating of the memorial arrangements, supervision of the memorial service, staff, setup and use of our equipment.
- F. Embalming** **\$825**
- ◆ Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. The State of Iowa requires embalming if the body is not buried or cremated within 72 hours from the time of death. Our policy requires embalming if there is an open casket during public visitation.
- G. Professional Care and Preparation of the Body** **\$250**
- ◆ Dress and cosmetize, disinfect and placement into casket or alternate container.

If you want to arrange a direct cremation you can use an alternative container. Alternative container encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).
