FY 2021-2022 Proposed Meeting Dates: Business Administrator Hoving presented the proposed meeting dates for FY 2021-2022. Mr. Hoving pointed out that the March 2022 meeting will be on the second Monday of March as opposed to usual third Monday. He stated this was necessary to ensure thirty days between meetings to consider and allow public comment on the proposed FY 2022-2023 budget. Managers Wage Recommendations for FY 2021-2022: Manager Listwan presented his wage recommendations to board for FY 2021-2022. Trustee Taglia made a motion; seconded by Trustee Clampit to approve the managers wage recommendations for FY 2021-2022. Ayes: Hensley, Taglia, Clampit. Motion carried.

<u>Manager's Report – February 2021:</u> Manager Listwan presented his report for the month of February. Trustee Taglia moved, seconded by Trustee Clampit to approve the Manager's Report for February 2021 and place it on file. Ayes: Hensley, Taglia, Clampit. Motion carried.

First Reading of FY 2021-2022 Budget and Appropriation Ordinance: Business Administrator Hoving presented the proposed FY 2021-2022 Budget and Appropriation ordinance for consideration. Mr. Hoving stated the ordinance appropriates a total of \$4,992,532.00 for the upcoming year of which \$3,233,118.00 is appropriated to the corporate fund for the day to day operation of the plant. The remaining appropriation is for the Improvement Fund \$340,000.00, Replacement Fund -\$110,000.00 and Debt Service Fund -\$1,309,414.00. Mr. Hoving further stated that this budget is the first balanced budget presented in a number of years. Mr. Hoving stated that a notice of public hearing will be posted in the Daily Herald newspaper. The public Hearing to be held at 6 PM on April 19, 2021 prior to the regularly scheduled Board meeting. The tentative budget will be posted for public review for the 30 days after publication. Trustee Clampit moved, seconded by Trustee Taglia to approve the publication of Public Hearing Notice in the Daily Herald newspaper 30 days prior to approval of FY 2021/2022 budget. Ayes: Hensley, Taglia, Clampit. Nays: None. Motion carried.
