FY 2021-2022 Audit Engagement Letter: Business Administrator Hoving presented the Audit Engagement Letter from Selden Fox to perform the annual audit for the year ending April 30, 2022. Trustee Agrusa moved, seconded by Trustee Taglia to approve the engagement letter as presented and authorize Selden Fox to perform the audit for the year ending April 30, 2022. <u>Sludge Hauling Contract Authorization to Bid:</u> Engineers Mark Halm and Darryl Carstensen presented the bid documents for sludge hauling. The engineers expect two to three bidders for this contract. <u>Life Insurance Renewal:</u> Business Administrator Hoving presented the proposal from MetLife to renew the District's life and disability insurance from July 1, 2022 through June 30, 2023. He stated that the carrier is raising rates by approximately 4.3%. The district budgeted for a 5% increase for FY 2022-2023 Trustee Taglia moved, seconded by Trustee Agrusa to authorize the renewal of the life insurance with MetLife. Ayes: Hensley, Taglia, Agrusa. Motion Carried.

<u>Dental Insurance Renewal:</u> Business Administrator Hoving presented the proposal from Delta Dental of Illinois for dental insurance coverage for the period of July 1, 2022- June 30, 2023. Delta Dental has once again held rates steady. The district budgeted for a 5% increase for FY 2023-2023. Business Administrator Hoving recommended renewing the dental coverage with Deltal Dental of Illinois. Trustee Agrusa moved; seconded by Trustee Taglia to approve the dental insurance renewal with Delta Dental of Illinois for a period of one year. Ayes: Hensley, Taglia, Agrusa. Motion carried.
