ORDINANCE NO. 555

AN ORDINANCE INCREASING THE USER CHARGES FOR THE SALT CREEK SANITARY DISTRICT, VILLA PARK, DUPAGE COUNTY, ILLINOIS

WHEREAS, the Salt Creek Sanitary District has adopted a system of charges for users of the District's sewage treatment works; and

WHEREAS, such charges are to be established annually by ordinance duly enacted; and

WHEREAS, the District's Board of Trustees desires to approve a base user charge rate increase of \$.30 from \$5.50 to \$5.80 by Ordinance; and

WHEREAS, \$.30 of the increase shall be for Corporate and Operating expenses.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE SALT CREEK SANITARY DISTRICT, COUNTY OF DUPAGE, STATE OF ILLINOIS AS FOLLOWS:

Section 1. The Salt Creek Sanitary District base user charge rate shall be \$5.80 per 1000 gallons of water usage, as determined by the appropriate water supplier, for bills issued on or after May 1, 2020.

Section 2. Thirty cents (\$.30) of the increase shall be placed into a fund or funds for Corporate and Operating Expenses. The result of this increase shall be that the amount of the base user rate to be placed into a fund or funds for Corporate and Operating Expenses shall be \$3.65 and the amount of the base user rate to be placed in a fund or funds earmarked for Capital Improvements including but not limited to Phases 3, 4, and 5 Debt Service to the wastewater treatment plant shall be \$2.15.
