

**ORDINANCE NO. 575**

**AN ORDINANCE OF THE SALT CREEK SANITARY DISTRICT, DUPAGE COUNTY, ILLINOIS ESTABLISHING A FIXED DEBT SERVICE CHARGE FOR THE SALT CREEK SANITARY DISTRICT**

**WHEREAS**, the Salt Creek Sanitary District, DuPage County, Illinois (the “*District*”) has heretofore been duly established and is now operating under the provisions of an act of the General Assembly of the State of Illinois, entitled “*Sanitary District Act of 1917*” (the “*Act*”), the provisions thereof being found more particularly at 70 ILCS 2405/.01, et seq.; and

**WHEREAS**, the District has incurred or anticipates incurring debt obligations to finance essential capital improvements to its sanitary sewer system infrastructure; and

**WHEREAS**, the Board of Trustees of the District has determined that a fixed debt service fee, assessed on a per-user basis, is necessary and appropriate to generate stable revenue to meet debt service requirements (the “*Debt Services Charge*”); and

**WHEREAS**, such a fee structure ensures equitable participation by all system users in supporting the District’s long-term capital investment; and

**WHEREAS**, the Debt Service Charge shall be \$6.00 per quarter per user; and

**WHEREAS**, the full revenues received from the Debt Services Charge shall be deposited into the Debt Service Fund as set forth herein and in the District’s Budget and Appropriations Ordinance for fiscal year 2025-2026; and

**WHEREAS**, the Board has determined that the establishment of the Debt Services Charge and the deposit of the full revenues received from the Debt Service Charge into the District’s Debt Service Fund as set forth herein is in the best interest of the health, safety and welfare of the residents of the District.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Salt Creek Sanitary District, DuPage County, Illinois, by and through its statutory powers, as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** There is hereby imposed a Debt Service Charge against each user of the services of the District or who owns real estate within the District or who otherwise comes within the jurisdiction of the District.

**Section 3.** The Debt Service Charge shall be included as a separate item on the wastewater treatment bill sent quarterly to each user.

**Section 4.** Beginning May 1, 2025, the Debt Service Charge as defined herein shall be \$6.00 per quarter per user.

**Section 5.** Beginning May 1, 2025, the revenues received from the Debt Service Charge shall be deposited into the District's Debt Services Fund.

**Section 6.** The Board of Trustees hereby authorizes and directs the General Manager, or his designee to undertake actions on the part of the District to effectuate the terms of this Ordinance as set forth herein.

**Section 7.** The officials, officers, and employees of the District are hereby authorized to take such actions as are necessary to carry out the intent and purpose of this Ordinance.

**Section 8.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.


**Section 9.** All ordinances, resolutions, motions, or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 10.** This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.
