Legal Services of North Dakota: Advancing Justice, Changing Lives

Each year, we assist thousands of individuals in navigating complex legal systems to achieve outcomes that profoundly affect their lives.

Legal Services of North Dakota (LSND) stands at the forefront of providing crucial civil legal assistance to low-income and marginalized populations throughout the state. As a nonprofit organization, we are committed to addressing the justice gap, ensuring that individuals and families facing lifealtering legal challenges have access to the support and resources they need.

LSND's work spans a wide range of legal areas, including housing stability, debt collection, public benefits, family law, elder rights, and protection for survivors of domestic violence and human trafficking. Each year, we assist thousands of individuals in navigating complex legal systems to achieve outcomes that profoundly affect their lives.

Housing issues make up a significant portion of LSND's caseload. Many of our clients face the threat of eviction due to rising housing costs, landlorddisputes, or unforeseen tenant financial hardships. By representing proceedings, in eviction tenants negotiating payment plans, enforcing housing rights, LSND helps families remain in their homes. This stability critical for preventing and maintaining homelessness educational and emotional well-being of children.



Another cornerstone of our work involves assisting survivors of domestic violence. LSND provides comprehensive legal support individuals seeking protection orders, custody arrangements, and divorce judgments. For these clients, legal assistance is often the first step toward free from abusive breaking environments and rebuilding a life of safety and independence.

LSND supports seniors throughout the state, addressing issues such as consumer fraud, Medicaid access, and estate planning. Many older adults in North Dakota live on fixed incomes and face exploitation or barriers in the legal system. LSND's advocacy ensures that seniors can age with dignity and security, free from predatory practices or unnecessary financial strain.

Rural and tribal communities represent another focus of LSND's efforts. Geographic limited isolation and access to resources that mean individuals in these areas often face additional hurdles when navigating systems. legal LSND's outreach programs and partnerships with tribes enable us to provide tailored services that respect cultural contexts while addressing pressing legal needs.

We are currently designing many selfhelp resources that are identified as a critical resource for North Dakotans qualify do not for representation or prefer to handle their legal matters independently. The new self-help website will offer easyto-understand forms, instructions, and virtual assistance to guide pro litigants through processes such as divorce filings, custody modifications, and small claims disputes. We are also developing self-help clinics across the state to provide a la carte legal advice to those facing court proceedings. This approach empowers individuals to take control of their legal challenges while ensuring they have the tools to succeed.

Beyond direct client services, LSND plays a vital role in education and advocacy. We host workshops, legal clinics, and public forums to inform North Dakotans about their rights and responsibilities under the law. For example, LSND frequently collaborates with organizations, local governments, and community groups to educate about tenant rights, consumer fraud prevention, and family law basics.





The impact of our work is tangible. In one case, LSND assisted a family of five in avoiding eviction after the father suffered a workplace injury that left him unable to pay rent. By negotiating with the landlord and connecting the family with rental assistance programs, LSND ensured they remained housed stabilized their finances. and another instance, LSND helped grandmother obtain guardianship of her two grandchildren after the children's mother was incarcerated. These outcomes are not merely legal victories; they are life-changing moments that bring hope and security to our clients.

Paralegals and legal assistants are integral to LSND's mission. Their meticulous attention detail, to and organizational skills, client communication expertise ensure that processes forward legal move smoothly and efficiently. Paralegals often act as critical liaisons, helping others to find LSND when they are unable to afford the fees of a private attorney. Many of LSND's clients simply cannot afford private attorney fees, making these connections vital in getting them the legal help they need.

Rules is rules, 'til they ain't!

(With apologies to my high school grammar teacher.)

I practiced law in rural North Dakota for over 30 years before I became a judge. And, while I didn't always get the time to follow his advice, I remembered clearly Justice Robert Vogel, who was a professor at the law school, telling us to read the rules at least once a year - not just the Rules of Evidence, but also the Rules of Civil Procedure, Rules of Criminal Procedure, Rules of Court and Rules of Appellate Procedure. In addition to those rules, we have Rules of Juvenile Procedure, Administrative Rules, local rules and the like. The various rules provide plenty of reading material, but unfortunately, many in the legal profession don't read them. (Plots are poorly developed and writing style stilted!)

For example, Rule 8.3(4) of Rules of Court requires the parties to a divorce to file a joint property and debt listing, at least 14 days prior to the trial. Each liability asset needs or numbered separately. Often the parties each submit their own listing, which complicates the matter for the Court as rarely do the parties list the assets and liabilities in the same order.




Likewise, Rule 3.2 of Rules of Court set out the timelines and procedures required for filing motions and the accompanying documents, timeline for filing a response, the timeline for filing a reply brief, and the requirements for securing a hearing. Rule 3.2 requires that if a party wants a hearing, they must request one in writing, and within 14 days of making the request, obtain a time and date for hearing. In our district, the requesting party must contact the calendar clerk to get the time and place for the hearing. Attorneys from New York City to Los Angeles routinely contact the calendar control clerk a month or so after the timeline has expired, requesting a hearing.

In the Southwest Judicial District, all include pre-trial civil cases a conference, and the rules require the pre-pre-trial attorneys have а conference between the attorneys to address concerns on the foundation of evidence, as well as pathways to narrowing the issues. (As an aside, our rules require local the Plaintiff/Petitioner to mark all exhibits using numbers, and the Defendant/Respondent to use letters, and the exhibits be pre-marked - but the Court often is presented with unmarked exhibits, or Defendant's exhibits marked with numbers perhaps the legal assistants need to take the lead on making their attorneys look good on this issue even though I doubt that information has ever been passed down to the assistants.)

I could go on and on. Kind of like athletics, there are rules for almost every situation in court filings and proceedings. However, too many parties ignore the rules, and that takes up the Court's time because, generally, we try to explain to the party at fault what the rule says and why we are denying what they are requesting or trying to do.

There are instances where the parties to a legal action can agree to disregard the rules. For example, one party may grant an extension of time to respond to a motion, or to file an answer. Giving notice of the extension of time, preferably by stipulation which is filed with the Court, is greatly appreciated. I recently worked on a matter where one party had failed to file a response within the time limits, and applicable rule indicated that failure to file is to taken as an admission by the non-responding party that they have no defense. So, I am working on writing the opinion and find out after hours of research and writing the parties agreed to give the responding party an additional 30 days. Needless to say, I was not pleased.



Some deadlines seem to have been ignored forever. For example, one appointed who is as personal representative of a decedent's estate is required to file an inventory and appraisement within 90 days of appointment. When I was practicing, that personal was rare а get representative would the information in my hands to complete that deadline - sometimes for over a While the delay may be year. attributable to the client, it may be the attorney who gets scolded (and we know who gets the blame when an attorney gets scolded, don't we?)

So, why burden the legal assistants with this complaint? I had secretaries that would remind me of some of the more obvious rules - telling me that discovery was due in one week according to our law office calendar, and reminding me of other deadlines. I analogize my reason to bringing this to your organization with the seat belt use campaign that children and grandchildren used – demanding Dad or Grandpa not start the car until everyone (including Dad or Grandpa) had their seat belts on and adjusted. Or, the children asking their parents to stop smoking. I'm not sure those burdens belonged to the children and grandchildren, but in many cases Perhaps worked. legal it the the assistants convince can attorneys to follow the rules.

The Battleship USS North Dakota and Its Silver Service

Did you know that every two years you can drink punch from an over-100-year-old museum artifact? Attendees at the reception marking the opening of the North Dakota legislative session are offered glasses of punch from the silver punch bowl that once sailed on the battleship USS North Dakota.

On Nov. 10, 1908, while President Theodore Roosevelt's Great White Fleet sailed around the globe, Mary L. Benton of Fargo broke the bottle of champagne that christened the battleship USS North Dakota. The state-of the-art North Dakota was the first dreadnought warship launched by the U.S. Navy, along with its sister ship, the USS Delaware. The two were officially commissioned into the Navy in April 1910.

Sponsor states gifting presentation silver to U.S. warships is a long-standing tradition. According to the Department of the Navy, "The silver forges a symbolic and historical link between the military crew of the vessel it is aboard and the civilian community from whence it came." In 1909, Gov. John Burke appointed a committee to raise funds, select designs, and oversee production of the silver. The committee solicited donations around the state. Fraternal organizations, local banks, school children, and many North Dakota citizens contributed to the fund. It took the committee nearly six years to raise the \$16,000 to pay for the 40-piece silver set (nearly \$500,000 today).

The Silver Service Committee hired the Manufacturing Company Rhode Island to create the set using the designs submitted by Hans Klimmek and Lilla Lorshbough, both of Fargo. The designs incorporated prairie roses, corn, wheat, and bison motifs to represent North Dakota, along with Navy symbols such as seashells, anchors, and stylized dolphins. The final set weighed 169 pounds and included a large punch bowl with a plateau, ladle and 24 serving cups, a pitcher with two goblets, a coffee urn, two candelabra, four serving trays, a salad bowl, a cigar box, and a centerpiece. Gov. L.B. Hanna presented North Dakota's gift to the battleship on May 5, 1915.

The U.S. Navy decommissioned the USS North Dakota in 1923, and the silver service sat in storage at the Hampton Roads Naval Yard in Virginia. In 1926, with the support of North Dakota Sen. Gerald Nye and Rep. James Sinclair, the 69th U.S. Congress passed Public Law No. 147 authorizing the secretary of the Navy to transfer custody of the silver service to the State of North Dakota. The service returned to Bismarck to a public reception at the Liberty Memorial Building on July 30, 1926. Shortly after the reception, the 40-piece set was transferred into the care of the State Historical Society of North Dakota.

Five months later, Gov. Arthur Sorlie began the tradition of using the USS North Dakota silver service at affairs of state. On Jan. 5, 1927, the Bismarck Tribune reported on Sorlie's inaugural reception: "Leaving the governor's office, guests passed the silver service of the battleship North Dakota, which was temporarily removed from its case in the historical museum. Punch was served from the massive punchbowl, which stood on a table with candelabra at either end." This custom continues to this day.

Every two years, at the request of the Governor's Office, State Historical Society staff remove the punch bowl and (sometimes) the candelabra from their permanent exhibit at the North Dakota Heritage Center & State Museum for use at affairs of state. This is most often the opening legislative sessions of or governor's inaugural ball. Each time a piece of the silver service leaves the ND Heritage Center building, it is accompanied by a staff member and National Guard escort. meticulously clean the bowl before and after its use. A clearcoat applied to the silver in 1926 keeps the pieces tarnish-free, so no polishing is required. Other pieces of the silver service have made appearances at state functions, but preservation concerns have limited their use. For example, the original ladle was used with the punch bowl until the 1960s when it broke during use.

Although the law passed in 1926 transferred custody of the silver service to North Dakota, legal title of the 40 items remained with U.S. Navy, essentially setting up a long-term loan. In 1997, staff at the State Historical Society formally requested permanent ownership of the silver service under Title 10 of the U.S. Code Section 7545 and 7546. With support from Sen. Kent Conrad, the secretary of the Navy approved the request, and the State Historical Society obtained legal title of the silver service.

Many of the pieces of the USS North Dakota silver service are on exhibit 361 days a year at the ND Heritage Center & State Museum. Visitors can also see a model of the battleship, alongside its original bell and bow plate. If you want to learn more about life on the battleship, check out this collection at the State Archives.

- Outlook tasks are amazing! I use and abuse them for everything I do.






Would you rather live where it only snows or the temperature never falls below 100 degrees? Why?

If you win a *million dollars*, what would be the first thing you buy? Why?


