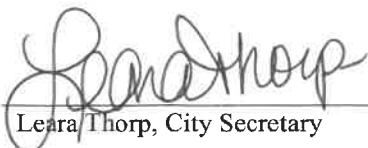




September 17th, 2025 at 7:00pm
City Council Special Meeting Minutes

1. **Call to Order:** Mayor Paul Eckeberger called the meeting to order at 7:02pm.
 - A. Roll Call and Certification of a Quorum
 - **Present:** Mayor Paul Eckeberger, Mayor Pro Tem Aaron Scott, and Councilmembers Rick Roberston, Roy Linder, & Brian LaFlower. **Absent:** Councilmember Larry Sutherland. Quorum Established.
 - B. U.S. & Texas Pledges of Allegiance – Led by Mayor Paul Eckeberger
 - C. Invocation – Led by Councilmember Brian LaFlower
2. **Public Hearings:** Public hearing called to order at 7:03pm, Mayor Eckeberger read the Impact Statement aloud, then opened the floor for comments, of which there was one. Public hearing closed at 7:08pm.

3. **Citizen Communication:** None.
4. **Action Items:** *City Council will discuss, consider, and take any action deemed necessary on items listed in this section, including the adoption of a minute order, a resolution, or an ordinance.*
 - A. Request from Aqua Services to Discuss Contract and Services – Jeremy Crocker and Sarah Neal, Aqua Services, were present. Items 4A and 4G were reviewed/discussed concurrently. Aqua Services discussed concerns and services with Council. No action.
 - B. 2025-26 Caney City Interlocal Agreement for Police Services – Council reviewed and discussed. Aaron Scott motioned to approve the 2025-26 Caney City Interlocal Agreement for Police Services. Rick Roberston seconded. All in Favor. Motion Passed.
 - D. 2025-26 Log Cabin Volunteer Fire Department Memorandum of Understanding (MOU) for fire protection services – Council discussed; it was recommended to take no action on the MOU.
 - E. Ordinance 89 Adopt 2025-26 Budget – It was noted there have been no changes in the proposed budget, and that the City will be shifting from adopting the budget by resolution to ordinance based on the advice of the City’s auditor. Council reviewed. Aaron Scott made a motion to ratify the property tax increase reflected in the budget. Rick Roberston seconded. All in Favor. Motion Passed. Aaron Scott motioned to approve Ordinance 89 to adopt the proposed 2025-26 Budget. Rick Roberston seconded. All in Favor. Motion Passed.
 - F. Review proposals for sewer plant fence repair – Council reviewed three bids to replace/move the sewer plant fence and discussed. No action for further research.
 - G. Review Health Services Contract Proposals for Water/Sewer System Operations – Items 4A and 4G were reviewed/discussed concurrently. Council reviewed contracts aloud, then discussed. The budget was discussed. No action.
 - H. Approve leasing order with D&M Fleet Management to order two 2026 Chevy Silverados for the Police Department – Council reviewed the quote and discussed. Rick Roberston made a motion to approve D&M open-end equity lease quote. Brian LaFlower seconded. All in Favor. Motion Passed.
5. **Adjournment** – Mayor Eckeberger adjourned the meeting at 8:57pm.
