REASON FOR EMERGENCY SUPPLEMENTAL

Pursuant to Section 551.045 of the Texas Government Code, the following agenda item will be added to the scheduled meeting (duly posted) and is authorized to be added to the agenda with more than one hour but less than three business days' notice to consider a matter of emergency or urgent public necessity requiring a meeting under said statutory provision is as follows: There exists an emergent and immediate need for appropriate action to respond to concerns arising from water/sewer leaks caused by fiber line installation, including resulting boil water notice. According to the Mayor, time is of the essence in moving forward to address this issue and prevent further damages.
