From this date forward Ordinance 137-**Speed Limits** shall now be known as Ordinance 13-**Speed Limits**.

### **ORDINANCE NO. 137**

AN ORDINANCE OF THE CITY OF LOG CABIN, TEXAS, ESTABLISHING MAXIMUM RATES OF SPEED ON RESIDENTIAL STREETS IN THE CITY OF LOG CABIN, TEXAS, INSTALLING SPEED HUMPS, FIXING FINES NOT TO EXCEED FIVE HUNDRED DOLLARS (\$500.00) AND PROVIDING FOR ERECTION OF SIGNS, PUBLICATION AND EFFECTIVE DATE. THIS ORDINANCE SUPERCEDES ANY SPEED LIMIT ORDINANCE PREVIOUSLY ENACTED BY THE LOG CABIN CITY COUNCIL.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOG CABIN, TEXAS:

## A. Establishment of Posted Speed Limit

**THAT** there is hereby established a maximum permissible rate of speed of twenty-five (25) miles per hour on all of the residential streets within the city limits of the City of Log Cabin, Texas. (This exempts speeds along FM 3054 and SH 198.) It shall hereafter be unlawful for any person to operate or drive any vehicle within the city limits of Log Cabin, Texas, at speeds in excess of this designated speed limit.

# **B.** Installation of Speed Humps

**THAT** multiple speed humps may be installed on the streets of the City of Log Cabin, Texas, at locations deemed appropriate by the city's police department, to curtail excessive speed within the city.

#### C. Penalties

THAT any person violating the provisions of this Ordinance shall be guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine not to exceed Five Hundred (\$500.00) Dollars.

## D. Signs, Publication and Effective Date

- 1. Signs indicating the speed limit approved by way of this ordinance shall be erected as soon as reasonably possible following the passage of this ordinance.
- 2. This ordinance shall become effective upon erection of the signs referenced in section D (1) and following the publication of this ordinance as required by law.
