ORDINANCE NO 19AC - GENERAL ELECTION

An ordinance calling for an election on May 4th, 2024 for the purpose of electing City Officials for the City of Log Cabin, Texas.

Be it ordained by the City Council of the City Log Cabin:

SECTION I – DATE, TIME, AND PLACE OF ELECTION ESTABLISHED

An election is hereby ordered to be held in the City of Log Cabin, Texas on May 4th, 2024, same being the first Saturday in May, between the hours of 7:00 a.m. and 7:00 p.m. Election to be held at City Hall, 14387 Alamo Road, Log Cabin, TX 75148, in the City Council meeting room for the purpose of electing the following officials:

Three (3) Council members, for a two (2) year term each

SECTION II – ELECTION JUDGES AND CLERKS

That a Presiding Election Judge and Alternate Judge be appointed to preside over the election, to be appointed by City Council at a later date. The Presiding Election Judge is granted authority to appoint as many election clerks (at least two (2)) as deemed necessary to properly conduct said election without prior or subsequent approval or ratification by the City Council of the City of Log Cabin, Texas.

That an Election Judge and Alternate Judge be appointed to preside over the Early Voting Ballot Board (EVBB), to be appointed by City Council at a later date. The Presiding Election Judge is granted authority to appoint as many election clerks (at least two (2)) as deemed necessary to properly conduct the Early Voting Ballot Board, without prior or subsequent approval or ratification by the City Council of the City of Log Cabin, Texas.

SECTION III – BALLOTS

That the official ballot of said election on May 4th, 2024 shall substantially comply with the laws of the State of Texas Governing Municipal Elections.

SECTION IV – VOTER PARTICIPATION

That only qualified voters shall be eligible to vote at said election in the City of Log Cabin, Texas.

SECTION V - EARLY VOTING

That Leara Thorp, City Secretary, is hereby appointed clerk for early voting. Early voting shall be held at City Hall, 14387 Alamo Road, Log Cabin, TX 75148, in the City Council meeting room. Early voting shall begin on April 22nd, 2024 and end on April 30th, 2024.

Early Voting by personal appearance will be conducted as follows:

- Monday, April 22nd, 2024 between the hours of 1:00pm to 5:00pm
- Tuesday, April 23rd, 2024 between the hours of 8:00am to 12:00pm
- Wednesday, April 24th, 2024 between the hours of 8:00am to 12:00pm
- Thursday, April 25th, 2024 between the hours of 1:00pm to 5:00pm
- Friday, April 26th, 2024 between the hours of 1:00pm to 5:00pm
- Saturday, April 27th, 2024 between the hours of 11:00am to 3:00pm
- Monday, April 29th, 2024 between the hours of 1:00pm to 5:00pm
- Tuesday, April 30th, 2024 between the hours of 8:00am to 12:00pm

Applications by mail must be received no later than the close of business on Tuesday, April 23rd, 2024 at 5:00pm. In addition, in-person delivery of a mail ballot to the early voting clerk shall be accepted on election day, pursuant to Texas Election Code, Section 86.006.

Federal Post Card Applications (FPCAs) must be received no later than the close of business on Tuesday, April 23rd, 2024 at 5:00pm.

SECTION VI – ELECTION NOTICE

That notice of said election shall be published in a newspaper of general circulation in Henderson County. Said publication shall not be less than ten (10) days nor more than thirty (30) days before the election. Additionally, the notice shall be posted on City's website and the bulletin board at City Hall used for posting meeting notices on or by the 21st day before the election (April 13th, 2024). The Mayor is hereby instructed to cause such notice to be given.

SECTION VII - RUN-OFF ELECTION (IF REQUIRED)

In the event of a tie between two or more candidates for a position that cannot be resolved in accordance with Texas Election Code, Section 2.002, a Run-off Election will be held on Saturday, June 15th, 2024 at City Hall, 14387 Alamo Road, Log Cabin, TX 75148, in the City Council meeting room. The polls shall be open from 7:00 a.m. until 7:00 p.m.

Early voting by personal appearance in the event a Run-off election is required shall be conducted at City Hall as follows:

- Monday, June 3rd, 2024 between the hours of 1:00pm to 5:00pm
- Tuesday, June 4th, 2024 between the hours of 8:00am to 12:00pm
- Wednesday, June 5th, 2024 between the hours of 8:00am to 12:00pm
- Thursday, June 6th, 2024 between the hours of 1:00pm to 5:00pm
- Friday, June 7th, 2024 between the hours of 1:00pm to 5:00pm
- Saturday, June 8th, 2024 between the hours of 11:00am to 3:00pm
- Monday, June 10th, 2024 between the hours of 1:00pm to 5:00pm
- Tuesday, June 11th, 2024 between the hours of 8:00am to 12:00pm

Applications for ballot by mail shall be mailed to Log Cabin City Hall, 14387 Alamo Road, Log Cabin, TX 75148. Applications by mail must be received no later than the close of business on Tuesday, June 4th, 2024 at 5:00pm. In addition, in-person delivery of a mail ballot to the early voting clerk shall be accepted on run-off election day, pursuant to Texas Election Code, Section 86,006.

Federal Post Card Applications (FPCAs) must be received no later than the close of business on Tuesday, June 4th, 2024 at 5:00pm.

SECTION VI – RUN-OFF ELECTION NOTICE (IF REQUIRED)

That notice of said Run-off election shall be published in a newspaper of general circulation in Henderson County. Said publication shall not be less than ten (10) days nor more than thirty (30) days before the election. Additionally, the notice shall be posted on the City's website and the bulletin board at City Hall used for posting meeting notices on or by the 15th day before the run-off election (May 31st, 2024). The Mayor is hereby instructed to cause such notice to be given.
