




ORDINANCE NO. 87

CITY OF LOG CABIN, TEXAS

CABLE TELEVISION FRANCHISE RENEWAL ORDINANCE

WHEREAS, the City Council of the City of Log Cabin, Texas, acting for and on behalf of the City (the "City"), does hereby ordain as follows:

Section 1. Title. This Ordinance shall be known as the "Cable Television Franchise Renewal Ordinance" and shall be referred to herein as "this Ordinance."


Section 2. Background. On August 13, 1988, the City, by Ordinance No. 18, granted to Northland Cable Properties Five Limited Partnership (the "Partnership"), a franchise to construct, operate, maintain, repair, replace and upgrade a cable television system for the provision of cable television, video programming and other programming and related services in the City (the "Franchise"). On June 18, 1998, the City, by Resolution, consented to the transfer of the franchise from the Partnership to Northland Cable Ventures LLC ("Northland"). On September 1, 1998, the Partnership assigned and transferred all of its right, title and interest in and to the Franchise to Northland. By letter, dated October 9, 2000, the City was timely notified of Northland's intent to renew the Franchise pursuant to federal law. The City, after due consideration of the franchisee's renewal request and following public hearings on the matter, has determined it is appropriate and in the best interest of the residents of the City to grant such renewal.

Section 3. Extension of the Franchise Term. The term of the Franchise is hereby extended for a period of fifteen (15) years, commencing August 13, 2003 and expiring August 12, 2018.


Section 4. Clarification of the Franchise. The Franchise allows the grantee under the Franchise to assign and transfer the Franchise from time to time (i) to its lender(s) for security purposes, (ii) to its affiliates, and (iii) to a purchaser of all or substantially all of the assets of the cable system serving the City.

Section 5. Effect of this Ordinance. Except as specifically set forth in this Ordinance and each of the documents referenced in Section 2 of this Ordinance, the Franchise shall remain in full force and effect in accordance with its terms.

THIS ORDINANCE HAS BEEN APPROVED AND ADOPTED AND SHALL BE DEEMED EFFECTIVE this 21<sup>st</sup> day of December 2000
