



## COMMITMENTS

Please initial the following commitments:

\_\_\_ I commit to remaining sober from all drugs and alcohol (*other than prescribed medications*). I will not enter the property under the influence of any drug or alcohol. I will not influence other housemates to engage in the use of drugs or alcohol.

\_\_\_ I commit to random drug and/or alcohol screenings administered on-site as well as room and property searches. Urine samples must be given within 1 hour of request. Refusal of the test/property search will result in immediate discharge from the program.

\_\_\_ I commit to maintaining a safe and sober environment. Use or possession of any drugs or alcohol is prohibited, including anything that may contain alcohol/drugs such as mouthwash, hand sanitizer, vanilla extract, cooking wines, etc.

\_\_\_ All prescription medication must be reported and turned into the House Lead. **NO EXCEPTIONS!**

\_\_\_ I commit to pay a \$200.00 *non-refundable* deposit upon entry (**methods of payment: Cash App, Venmo, Chime, Western Union or Walmart-to-Walmart: NO CASH, NO MONEY ORDERS, NO CHECKS**)

\_\_\_ I commit to pay my program fees on time: \$200.00 weekly due each Friday by 10pm; \$650 monthly due 1st of each month (*disability rate; must be pre-approved by Director*): **failure to pay on time will result in discharge**

\_\_\_ I commit to a 30-day probationary period beginning the first day of residence, in which I can be discharged for any undisclosed reason. During probationary period, I will abide by a 9pm curfew.

\_\_\_ I am eligible to receive two 24 hour passes each month which can be used separately or concurrently (no passes will be given during probationary period). House Lead/Program Director reserve the right to deny pass.

\_\_\_ I commit to a 10pm curfew. I will return to the residence no later than 10pm and remain inside the residence until 6am (*exceptions can be made for work with approval from leadership and proper documentation*)

\_\_\_ I commit to attend 3 approved 12-step meetings and a house meeting each week set by House Lead.

\_\_\_ I commit to obtaining a sponsor within the 12-step program and actively participating in the process.

\_\_\_ Sign-in/Sign-out is mandatory. I commit to sign-in/sign-out every time I enter and depart premises.

\_\_\_ I commit to providing my own personal items (*such as hygiene products, toilet paper, laundry detergent, etc*) once employed and receiving paychecks (*until paycheck received, our program will provide necessary items*).

\_\_\_ I commit to refrain from any/all violence including horse play. Violence will lead to immediate discharge.

\_\_\_ I commit to refrain from any/all harassment. This includes but not limited to racial slurs, threats, foul language, and aggressive communication. Harassment will lead to immediate discharge.

\_\_\_ I commit to respecting Quiet Hours 10pm-7am. (*See Quiet Hour Rules for specific residence*)

\_\_\_ I commit to In-House Visitation Policies. Only current residents and sponsors are allowed on the property; sponsor visits require approval from leadership.



\_\_\_ I commit to following smoking policies. Smoking is never allowed inside residences. Smoking is permitted outside in designated areas. Utilize ash trays for butts; do not throw on ground or in street.

\_\_\_ I commit to making my bed each day.

\_\_\_ I commit to maintaining my personal hygiene (*shower, brush teeth, change clothes, etc*).

\_\_\_ I commit to following the laundry policy (*specific to each residence*) to wash my own clothes, bed linens and towels.

\_\_\_ I commit to complete chores as assigned by leadership.

\_\_\_ I commit to respecting the residence and fellow housemates by keeping my personal area and common areas clean (*throw out trash, clean up spills, no clutter, washing/drying dishes and cookware, etc*).

\_\_\_ I commit to respecting others' privacy and personal space by utilizing common areas to socialize. Residents are not allowed in other residents' bedrooms.

\_\_\_ I commit to only congregating at other houses in the program when accompanied by leadership.

\_\_\_ I commit to find employment within 7 days. Program Director reserves the right to approve employment.

\_\_\_ Until employed, I commit to leave the property Monday through Friday from 8am to 4pm diligently job searching or at the local library filling out applications.

\_\_\_ Stealing of any kind will not be tolerated and will lead to immediate discharge.

\_\_\_ I commit to maintaining a safe environment by refraining from bringing any weapons onto the property.

\_\_\_ I commit that if I make the decision to leave the property, or am discharged, I am responsible for removing all of my personal belongings within 24-48 hours: items not taken are considered abandoned and forfeited.

\_\_\_ I commit to be responsible for all my medical and mental health needs (*see Resources for guidance*).

\_\_\_ I commit to be supportive and encouraging to my brothers and sisters in the program, including bringing all concerns of housemates' actions to leadership.

\_\_\_ Disciplinary actions are decided based on the level of violation which include: verbal warning, written warning, behavioral contract, or immediate discharge.

\_\_\_ I understand that I am a resident not a tenant and can be discharged at any time if I am repeatedly uncooperative, have a bad attitude, do not follow directives, or break house rules or policies.

\_\_\_ I commit to a 3 Strike Policy. Accumulation of 3 strikes will result in discharge (*violation of certain rules will result in immediate discharge*).
