- 2026 Gravel Road Contract consideration: Isabella County Road Commission has provided their suggestion for the 2 miles of gravel to be upgraded in 2026. Pleasant Valley Road from Brinton to Woodruff is being suggested. Please be prepared to give an approval on gravel roads at our Annual ICRC meeting. No date for the ICRC meeting has been determined at this time.
- Auditor Barry Gaudette has retired and Rolland Township is looking for a replacement. It appears some Isabella County Township have hired Boge, Wybenga and Bradley Accounting firm out of Mt. Pleasant. Other townships as well as Isabella County Road Commission are utilizing Rob Klaczkiewicz out of the Saginaw area. Clerk Butler currently has a bid from Boge, Wybenga and Bradley and will reach out to Mr. Klaczkiewicz for a bid.
- Board of Review vacancy by the resignation of David Marston. Supervisor Shaw has spoken with a couple of residents to see if they would be interested in the position. Supervisor Shaw has spoken with and highly recommends Adam Brookens to replace Mr. Marston. A motion to hire Jacki Fredricks to be Tech Support for the Board of Review for \$150 per year was requested.
