## Day One Wednesday 17th April

After pick up from your door as usual, you'll be transferred to the airport for your flight to Melbourne. Here, Peter will meet you with the bus and your Great Ocean Road adventure begins. We're off to Geelong first – our home for two nights. Dinner at our Hotel tonight (D)

## Day Two Thursday 18th April

After a delicious breakfast at our Hotel, we're off to Barwon Heads on the southern coast of the Bellarine Peninsula. It's a popular seaside community with the shallow sandy shoreline of the Barwon River and the windswept beaches that front Bass Strait. Its twin coastal town is Ocean Grove.





Point Lonsdale and Queenscliff are our next stops before we catch the ferry to Sorrento. Be charmed by the historic seaside village of Queenscliff with its elegant Victorian-era buildings, art galleries and shops. Queenscliff is surrounded on three sides by water, giving the town large stretches of coastline, consisting of a combination of sandy beaches, rocky outcrops, cliffs and historic piers. At Shortlands Bluff is the Queenscliff Lighthouse which was built in 1862 and includes a lookout near the base.





You'll love our ferry ride across to Sorrento. Experience the beauty of Melbourne's Port Phillip Bay on a bay crossing with Searoad Ferries. The 40-minute sail between Queensclliff and Sorrento is pretty cruisy compared to the over three-hour drive around, saving time, offering more sightseeing and a Bay cruise. Spot dolphins, pass golden sandy beaches, rugged coastline and clifftop mansions. All the while, you can sit back and relax. There is plenty of fresh sea air, viewing decks inside and out, and spots to enjoy a coffee, wine or beer.





Sorrento is a delightful seaside holiday and resort town near the entrance to Port Phillip Bay at the narrow western tip of the Mornington Peninsula. it has become a magnet for people wanting cruises in Port Phillip Bay and ferry trips across to Queenscliff. It is essentially a fashionable summertime holiday resort well supplied with pubs, cafes, coffee shops, restaurants, pancake parlours, ice-creameries and galleries. The narrow strip between Port Phillip and Bass Strait is now urbanised and there are a number of attractive ocean beaches, known for their surf and rugged shoreline, which lie to the south of the town centre.





At Arthur's Seat, you can ascend to the highest viewpoint on the peninsula for breathtaking views. A walk up the 304-metre granite hill of Arthurs Seat is a peninsula ritual. Your reward today is an amazing view of golden beaches, Mornington and Bellarine peninsulas, and the twinkling glass towers of Melbourne, far across the bay.





For a bird's eye view over Port Phillip Bay climb aboard the Arthurs Seat Eagle, a state-of-theart gondola which soars high above the trees. As you soar above the treetops, you will be immersed within the natural setting and beauty of the Australian landscape. Take in the abundant views across Port Phillip Bay towards the Melbourne city skyline and beyond. Let's head back to Geelong now. Dinner at our Hotel again tonight. (B)(D

## Day Three Friday 19th April

We'll depart Geelong after brekky and head to Torquay. Home to some of Australia's best-known surf beaches, Torquay marks the official beginning of the Great Ocean Road. Magnificent coastal views dominate towards the beach towns of Anglesea and Lorne.





As you make your way to Apollo Bay, you'll travel along cliff tops with incredible views and alongside wild beaches – take time to stop at the various scenic lookouts for photos, or step down onto the beach for a stroll.

From Apollo Bay, follow the Great Ocean Road into the lush Great Otway National Park, and turn off to the Cape Otway Lightstation — the oldest surviving lighthouse in mainland Australia. Climb to the top, 90 metres above sea level, to glimpse the meeting point of Bass Strait and the Southern Ocean. Built in 1848, the lighthouse was known as the "Beacon of Hope" Hundreds of lives were lost along this shipwreck coast — a sad but fascinating history which lead to the building of the Lightstation on the cliff's edge. For many thousands of 19<sup>th</sup> Century migrants who spent months travelling to Australia by ship, Cape Otway was their first sight of land after leaving Europe, Asia or North America.





From Cape Otway, we'll travel on to Port Campbell – our home tonight. Dinner at a local restaurant tonight. (B)(D)

## Day Four Saturday 20th April

After brekky at a local restaurant, we are in for a real treat. Port Campbell National Park is world famous for its extraordinary collection of wave-sculpted rock formations and the Twelve Apostles.





Loch Ard Gorge, site of a 19th century shipwreck 'Loch Ard', as well as the Island Archway and London Bridge are other highlights. The Island Archway collapsed in 2009, highlighting the fragile and ever-changing nature of Victoria's coastline.

We will be lucky enough to view these magnificent structures on a luxury helicopter flight. We'll soar above the 12 Apostles and see the splendour of the Great Ocean Road from new heights. We'll climb above the crowds to experience the best of Victoria's Shipwreck Coast.





A change of pace now as we visit Timboon, a typical rural centre located in a rich dairy area where the production of milk, cheese and butter is still central to the local economy. It is known in the area for Timboon Fine Ice Cream and Timboon Farmhouse Cheese. The other major industries in the area are timber cutting and lime production.





Stretching out across 32 kilometres along the coast of Victoria between Peterborough and Warrnambool, the Bay of Islands offers astounding ocean views and a collection of fascinating geological features. Here, you can soak up a landscape that is packed full of sheer cliffs and unusual rock stacks, as well as sprawling heathland that is peppered with colourful wildflower displays. Warnambool is our home for the next two nights. Dinner at our Hotel tonight. (B)(D)

## **Day Five Sunday 21st April**

After a delicious brekky at our Hotel, we'll drive through the pretty little town of Port Fairy. Uncover history in every corner of this charming fishing village at the end of the Great Ocean Road. The last destination on Victoria's famed Shipwreck Coast, Port Fairy boasts wide streets lined with 19-century cottages, great Norfolk pines and old stone churches.





Then it's on to Portland. Portland's waterfront is alive with activity – see big ships from around the world come in to load up local produce and the local fishing fleet unload its catch. Take a ride on the foreshore cable tram, spot seals at Cape Bridgewater and watch blue whales off Cape Nelson. With a 7.4km route meandering along Portland's spectacular foreshore, the Portland Cable Tram is a must-do for any visitor to town. The Portland Cable Tram offers passengers a taste of yesteryear on board lovingly restored and modified saloon and grip cars.





The iconic tram stops at the WWII Memorial Lookout Museum, Whale viewing platform, Portland Botanic Gardens, Portland Maritime Discovery Center, Powerhouse Motor and Car Museum and Tram Depot. The Portland Cable Tram Depot is more than just a tram stop. Housing a museum of historic local artefacts, featuring the largest private gemstone collection in the Southern Hemisphere, local model railway club display and gift shop. Lunch is included here today. Dinner at our Hotel tonight before another treat!

As night falls, step into Flagstaff Hill village to experience dramatic stories of Australia's rich maritime history, told vividly through the multi-million dollar Soun d and Light Show Experience. See the village come to life and experience the stories told through projections onto a nine-metre water wall.





Be taken on a journey into the past where those seeking a new life in Australia braved the perils of the Southern Ocean and where the livelihoods of men depended on capturing the largest mammals the world has ever seen.

## Day Six Monday 22<sup>nd</sup> April

We farewell Warnambool after breakfast and head to South Australia – but not before a visit to Dunkeld – the gateway to the Grampians. Here we can enjoy striking views of Mount Sturgeon and Mount Abrupt whichever way we turn.





We'll then travel through Hamilton on our way to Mt Gambier. Mt Gambier is full of Geological Wonders. It is often what you can't see that forms the biggest adventure of all. What is beneath us is like nowhere else in the world. As the volcanoes rocked the earth over 5,000 years ago, lava caves formed, an array of cenotes (sinkholes) developed and breathtaking lakes established the limestone foundation of Mount Gambier. This created a region that is truly unique.



Mount Gambier is one of few cities in the world to be established on the slopes of a volcano, but visitors needn't be nervous; the imposing landmark last erupted 5000 years ago. The Blue Lake/Warwar and Valley Lake/Ketla Malpi craters formed during the eruption, but according to the Dreamtime stories of the Boandik Aboriginal tribe, they were the work of the giant Craitbul; every time he lit a campfire, it was doused by emerging underground water, leaving gaping holes in the ground.





**Little Blue Lake** is a water-filled doline in the Australian state of South Australia located in the state's south-east in the locality of Mount Schank about 20 kilometres (12 mi) south of the municipal seat of Mount Gambier. It is notable locally as a swimming hole and nationally as a cave diving site. It is managed by the District Council of Grant and has been developed as a recreational and tourism venue. Dinner at our Hotel tonight. (B)(D)

## Day Seven Tuesday 23rd April

As we depart Mt Gambier after breakfast, we head to Robe. This cute but classy seafaring village has been an international port since the 19<sup>th</sup> Century and was the landing pad for Chinese immigrants in the 1800s drawn to Australia in search of gold. You'll love its unique historical landmarks glittered throughout the town AND the pristine Guichen Bay.





Nestled on the picturesque waters of Lacepede Bay and home to the famous 'Larry the Lobster', Kingston is an ideal place for holidaymakers and families to relax and unwind. The Cape Jaffa Lighthouse is a unique legacy of the maritime history of South Australia.



You'll love the Silo Art in Coonalpyn. The tiny rural town of Coonalpyn is showing signs of rejuvenation and community pride. At the Coonalpyn Silos, the artist decided to paint 5 local school children to represent Coonalpyn's Hope for the Future. It's really changed the fabric of the town and brought them together in a way that hasn't happened in a long time.





Surrounded by rolling hills, picturesque valleys, tall gums and farming country, the charming historic ton of Strathalbyn is recognised as one of South Australia's loveliest rural destinations. Visitors to Strathalbyn can see many fine examples of its rich history, with an abundance of heritage buildings dating from 1839 that are still being used today. One of the must-do activities is to enjoy the rich history of the past in the antique stores located around High Street. You'll find a treasure trove of antiques and collectables all within a short walking distance. The Soldiers Memorial Gardens and the Angas River run through the centre of town.





Murray Bridge is our over night destination, a bustling rural town sitting in prime position on the banks of the Mighty Murray River. Our final dinner is at our Hotel tonight. (B)(D)

#### **BOOKINGS, DEPOSITS AND PAYMENTS**

In order to secure your booking, we require a deposit, per person, within 7 days of making your booking. Deposit amounts are outlined in each itinerary. \$1,500 deposit required for this Great Ocean Road Tour

When making a booking for yourself you warrant that you are 18 years of age or older. If you are making a booking on behalf of a minor/s you warrant that you are their parent or legal guardian and take full responsibility for said minor/s and will not hold us or a Supplier responsible for any breach of these term and condition by any minor under your control.

When making a booking for yourself or on behalf of another person or on behalf of a minor, you warrant that all information provided by you is true and correct. We take no responsibility for any errors or incorrect information provided by you and will not be held responsible for costs, fees, penalties or payments incurred for errors or incorrect information provided by you.

All deposits are non-refundable for changes of mind or cancellations by you (subject to your rights under the Australian Consumer Law).

You are required to pay the balance payment at least 60 days prior to the tour date. For tour bookings made within 60 of the tour date full payment is required on booking.

Failure to make payment by the due date **may** result in your booking being cancelled and deposits forfeited.

Payments made by direct deposit may take up to three business days to process. If you are paying by this method, you will need to make the payment at least three business days prior to the actual due date. You must notify us once your payment has been made.

Payments made by personal cheque (excluding bank cheques) require five business days to process. If you are paying by this method, you will need to make the payment at least five business days prior to the actual due date. You agree not to stop payment of the cheque even when you cancel a booking. You agree that we may apply the proceeds of the cheque to satisfy any liability you have to us or to a Supplier, including any liability in respect of cancellation fees, before refunding the balance to you

#### **CHANGE AND CANCELLATION FEES**

Please be aware that some confirmed bookings are not refundable if cancelled and may not be transferable to another date or otherwise changed. Alternatively, a change may only be permissible subject to payment of an additional fee or charge. Changes and cancellations of confirmed bookings may incur fees from Suppliers. It is your responsibility to check if a booking is non-refundable or will incur charges for changing it before placing the booking.

If you cancel your booking, we reserve our right to charge you cancelation fees on the following basis: -

- Bookings cancelled more than 60 days from the tour date will not incur a fee subject to any additional non-refundable fees or charges from Suppliers.
- Bookings cancelled not more than 59 days but not less than 15 days from the tour date will incur a fee which is 50% of the Tour Price subject to any additional non-refundable fees or charges from Suppliers.
- Bookings cancelled not more than 14 days but not less than 8 days from the tour date will incur a fee which is 75% of the Tour Price subject to any additional non-refundable fees or charges from Suppliers.
- Bookings cancelled within 8 days from the tour date will be required to pay for 100% of the Tour Price.
- Bookings cancelled after the tour date will be required to pay for 100% of the Tour Price.

Please be advised that a \$50 administration fee (per person) will be charged on ALL cancellations regardless of the number of days' notice given.

To cover cancellations as a result of illness or loss of baggage, we strongly encourage passengers to arrange travel insurance. We now sell *Covermore* travel insurance and just need your date of birth to be able to provide you with a quote.

#### REFUNDS

Your entitlement to a refund for cancelled bookings is subject to the relevant Supplier's terms and conditions, and our cancelation fees as outlined described above.

If you are entitled to a refund then, subject to the Supplier's terms and conditions, we will arrange for it to be supplied to us on your behalf, unless we expressly agree with you otherwise.

If we are managing or arranging a refund for a cancelled booking on your behalf it will not be paid to you until the Supplier provides the refund to us, and we will not be liable for any delay on the part of the Supplier. Be aware that typically airlines will take between 60-90 days to process a refund.
