Day One Thursday 25th April

After pick up from your door as usual, you'll be transferred to Brisbane for your flight to Adelaide. Here Peter will meet you at the luggage carousel and your Adelaide to Alice Springs Adventure begins. Let's go for a drive to the seaside and enjoy some free time in beautiful Glenelg. It's the main commercial centre for a very prosperous agricultural area. But copper mining was once the main industry when the town was founded in 1859. The town has many historical buildings with Cornish architecture including royal Exchange and Wombat Hotels.



Wallaroo is our next stop, one of the most popular coastal escapes on the Yorke Peninsula. Wallaroo is a seaside paradise plonked in prime position on the west coast of the peninsula, The holiday hotspot is a favourite family destination and boasts sandy beaches perfect for swimming, a rich maritime history, chic cafes and fishing fanatics that flock to Wallaroo to cast a line off the famous jetty





Port Pirie is an historic seaport town and home to beautiful heritage buildings, fascinating industrial history and a blossoming cultural precinct. It's also known as the Gateway to the Flinders Ranges.





In Port Augusta, we'll visit Wadlata Outback Centre, the essential first stop for visitors to this part of the world. Wadlata offers a memorable introduction to the area's culture, heritage, settlement and modern development. Learn about the aboriginal people, the explorers, stockmen, pastoralists and miners who opened up the outback – and about the landscape, plants and animals. Pedal the radio as School of the Air students recite their lessons, have a go at Morse Code, see the Outback Picture Show, "tour" the Leigh Creek Coal Fields and Olympic Dam Mine – and so much more. Dinner at our Hotel tonight. (B) (D)

Day Three Saturday 27th April

After a delicious breakfast at our Hotel, we're off to Woomera, an artificial town specifically designed by the Long-Range Weapons Board of Administration to provide accommodation and facilities for personnel - scientists, technicians and ancillary staff - who came to work at an isolated experimental station which was used to test rockets, weapons and missiles



We'll enjoy the Visitor Centre and lunch here today before heading to Coober Pedy, the Opal Capital of the world. Coober Pedy and its surrounds is often described as being moon-like with its landscape dotted with shafts and mullock heaps from opal mining activities. With a population of around 2,500, there are more than 45 nationalities represented creating a very ethnically diverse community.





It's believed that the soldiers that returned from the trenches of WWI introduced the idea of living underground in homes commonly known as dugouts. The miners quickly realised the benefits of living underground to escape the heat of the summer and the cool winter nights. It's estimated that approx 50% of the population live underground now. Some mansion style homes spread up to 450 sq m underground. Dinner at a local restaurant tonight. (B)(L)(D)

Day Four Sunday 28th April

After brekky at our Hotel, some free time to explore the town. Then, after lunch (own expense) we're in for a real treat as we tour with a local company to find out more about this fascinating town. You'll love our visit to Umoona Opal Mine and Museum



We'll take a walk through our museum where you will find information on Aboriginal and European settlement in the area. Step back into Australia's ancient past and view fossils from the South Australian Museum. We'll experience underground living in a display home or see what it was like digging for opal in an authentic mine.





We'll find one of the most peculiar churches in the world and certainly the most unusual Serbian church on the other side of Earth. Quite literally. Not only is it situated in a desert in Australia, but it's also hidden underground. We're talking about the Serbian Orthodox Church.

Another part of our tour takes us to Kanku – Breakaways Conservation Park which is Aboriginal owned and is a registered aboriginal heritage site. It consists of colourful low hills which have broken away from the Stuart Range, hence the name Breakaways.



There are 2 lookout points which highlight the open spaces and colourful environment, leaving an impression of the long-gone inland sea that our early explorers dreamt of. Colourful outcrops have been used in a number of films and ads, while Panorama Hill in the middle, featured in Mad Max Beyond Thunderdome and Ground Zero. As the day goes by, the passing of the sun changes the desert colours, creating photogenic scenes that appear surreal.





The road back to Coober Pedy takes us east along the hills to the dog fence. This 2m high wire barrier stretches for over 5,300 km across 3 states – to protect the sheep country ion the south from dingos. The desert-like moonscape along the fence, with its fossilised shells, grey soft clay dirt and cracks that appear to be bottomless, have been nicknames the "moon plain". It too has been the scene for numerous movies.





We'll also visit a private claim in the opal fields. What a fascinating place.

Late this afternoon, we'll check out the Big Winch 360 complex that perches over Coober Pedy, providing expansive views to the Breakaways and the unique and often quirky Coober Pedy. We'll enjoy the best of SA food and wine in the remarkable cafe and bar.



Then we're in for a real treat An Outback Cinematic Journey unfolds in an experience that immerses and surrounds visitors deep into the heart of.... somewhere. Coober Pedy's Big Winch 360 – the Outback's newest world class attraction and home to Australia's first permanent 360° Circlevision cinematic experience. Vision and sound surround the audience in a show as big as the outback, and as unique as the people that call it home.

REFUNDS
