PUBLIC COMMENT:

Dan Pagel (8615 Short Cut Road) provided the Board with a copy of a letter he distributed to his neighbors regarding tannerite explosions in the area. Mr. Pagel advised that these explosions have been happening in his neighborhood for the past two years and specifically addressed an explosion

that occurred on December 26, 2022. Mr. Pagel has contacted Clay Police and ATF regarding the use of tannerite in the area. The noise from the explosions is not legal. The Supervisor addressed Mr. Pagel's concerns and will see what action can be taken.

Laurhn Halabis (8427 Samantha) addressed the Board requesting an ordinance amendment to allow backyard chickens in residential area. She is recommending up to six (6) laying hens be allowed in a residential area. The ordinance currently requires a five-acre parcel to have barnyard animals. She also advised that many cities and other municipalities have changed their ordinances to allow chickens on smaller lots in residential areas. The Supervisor advised the ordinance was very clear on the requirements to retain farm animals but he will talk with the Township Planner.
