MINUTES OF THE REGULAR MEETING OF THE IRA TOWNSHIP BOARD OF TRUSTEES MAY 2, 2022

The Ira Township Board of Trustees met in the board room of the Ira Township Hall on May 2, 2022 at 7:00 p.m. The meeting was called to order followed by the Pledge of Allegiance.

MINUTES:

T. Eder moved to approve the minutes of the 4/4/2022 regular and 4/11/22 special meetings, supported by S. Ruhlman. All voting yes. Opposing: None MOTION CARRIED

Additional correspondence received from Attorney John A. MacKenzie of Maddin Hauser for property located at 8361 Broadbridge Road, (the "Property").

Attorney Jordan Segal, appearing on behalf of the Maddin Hauser firm, addressed the Board regarding clients, Raed Kasmikah and Faik Yaldo, who have requested that the Township amend Section 17.004F. of Ordinance No. 105 Prohibition of Marihuana Establishments Ordinance and an accompanying amendment to the Township Zoning Ordinance to permit a medical marihuana grow facility as a permitted use at the Property.

Mr. Segal stated the following:

- The Property would be used for a marihuana grow facility only with plants transported through-out the state of Michigan;
- Amend Section 17.004F. to remove the appropriate section to allow the facility;
- The facility would generate income for the Township; increase property values around the facility; they would be good neighbors and hire 10-15 Ira Township residents to work at the facility;
- In November 2018, Township residents voted 55% to 45% in favor of Ballot Proposal 2018-1;
- If developed the Property would be a limited operation as a grow facility only;
- Owner would offer a buffer zone to all neighbors and traffic would be a minimum as this is a grow facility only;
- Owners would be leasing Property to a third party;

The Board discussed and asked for additional information from Attorney Segal. Discussion included, current zoning of the Property and whether this use is permitted; if allowed would this affect other properties in the Township where other owners would want to open like-type facilities; odor and other issues related to a grow facility; neighboring communities have allowed this in industrial zoned areas only; confirmation by Attorney Segal that his clients knew about the Township's ordinance before they purchased the Property; how would this development increase neighboring property values, and other discussion items. After diligent discussion, the Board took the following action.

T. Eder moved to decline Mr. Segal's invitation to amend our Ordinance at this time, to allow for further cultivation of medical marijuana in the Township, supported by S. Ruhlman.

Sanitary Sewer Cleaning and Inspection

S. Ruhlman moved to accept the recommendation of the DPS Superintendent and approve the proposals from IMEG, in the amount of \$115,400, and from Marquis Electrical Services, in the amount of \$30,395.00, for a total project cost of \$145,795.00 for improvements to the water plant, supported by T. Eder.
