IRA TOWNSHIP PAVILION RENTAL AGREEMENT

Ira Township has one large pavilion available to rent from April through October. The pavilion is located on the northeast side of the Municipal Park, near the trail entrance. The pavilion has a rental fee of \$50 for Ira Township residents and \$100 for non-residents. Renter must be at least 21 years of age to rent. Renter must be present the entire duration of the event. If the event includes youth under the age of 18, there must be a ratio of 1 adult to every 10 youths.

Reservations for the season will be taken at the Ira Township Offices, 7085 Meldrum Road, Monday through Thursday, 7:00 am to 5:00 pm, closed from 12:00 pm to 1:00 pm. No telephone reservations or mail-in requests accepted. Reservations begin March 1st for the upcoming season. (If the Township offices are closed on March 1st, reservations begin the first regular business day).

Confirmation of reservation and payment can be made with cash, check, or credit card, made payable to Ira Township, on a first come, first served basis. Reservations can be made for the current season only. Payment is due at the time the reservation is made. Proof of identification and residency is required.

For the duration of the rental period, Renter must assume the responsibility to have adequate safety measures in place to protect the safety of those in attendance, such as, access to a telephone for 911 services and first aid materials. Materials/equipment will not be used in a manner that could cause bodily injury or property damage. Rental of a Ira Township Park does not imply co-sponsorship by the Ira Township Parks and Recreation Commission. Please do not include Ira Township's telephone number as a contact for your event.

The park is only open from dawn to dusk and closed from dusk to dawn. Your pavilion rental is for the entire day the park is open.

Ira Township only rents the large pavilion area. The rest of the park is open for public use to include horseshoe and gaga ball pits, volleyball and basketball courts, playground areas, small pavilion, disc golf course and trails.

All trash, garbage and litter are to be deposited in the refuse containers provided. For large pavilion rental, all trash will be removed by the applicant of the rental agreement.

The following are **NOT PERMITTED** at any facility: water balloons, silly string, petting zoos, rides, amusements, inflatable games, dunk tanks, generators, hot or cold air balloons and ice cream trucks. Gas or charcoal grills (must have drip plates) are permitted but must be disclosed with Ira Township at the time of the permit application. Any fire source, be it propane or charcoal, must be contained in approved containers. Open fires, wood fires, outdoor fryers and boilers are not permitted no matter how contained.

The consumption of alcoholic beverages at the Ira Township Parks and facilities are prohibited. No glass containers are permitted in any of the parks. These facilities are also non-smoking.

NO REFUNDS FOR INCLEMENT WEATHER. Refunds are available for cancellations made 10 or more days prior to the reservation date only.

General Clean Up and Removal of Trash is the responsibility of the applicant.

The Board of Trustees shall have the authority to waive or modify any fees associated with the use of the Ira Township large pavilion and reserves the right to modify these policies as necessary.

IRA TOWNSHIP PARK RULES AND REGULATIONS

The purpose of these Rules and Regulations is to protect and preserve the resources and property of the parks and to promote the safe enjoyment of the parks by all park visitors.

No hunting, trapping, or molesting of animals shall be permitted and no firearms or any other form of weapon, including but not limited to, sling shots, B-B guns, knives or clubs shall be brought into the Township Parks.

No alcohol or smoking is permitted in the parks. No glass containers are permitted in the parks.

No person shall operate a motorized vehicle including, without limitation, a car, truck, motorcycle, motorbike, dirt bike, trailer, 3-wheeler, 4-wheeler, snowmobiles, or any other road vehicles or recreation vehicle anywhere other than the parking lot at the township parks.

Pets must remain on a leash (maximum ten feet in length), always kept under physical control, and not be a nuisance or a danger to other park users. Pet owners are required to remove the pet's fecal deposits from the park grounds and place their waste in a suitable receptacle. There are bags and receptacles located in the park.

Vehicles are not allowed to drive off roads or parking lots. Equipment and supplies must be carried in, moved by hand cart or wagon only.

There will be no soliciting in the parks.

No overnight camping is allowed in any Township Park.

No signs are allowed except temporary signs identifying a group location using the park pavilion or decorating the pavilion for a rental event. No staples, nails or tacks are to be used on picnic tables or building surfaces.

Fires: No fires are permitted except in camp stoves and designated barbecue grills. No fireworks of any kind shall be permitted in any Township Parks.

Conduct: No person shall be drunk of disorderly. No person shall make an unreasonable noise, or profane, obscene, or offensively coarse utterances, gestures or displays, or communicate any unwarranted and grossly abusive language to any person.

Damage to park property: No person shall obstruct any walk or drive in any public park or playground and no person shall injure, mar, deface or damage in any manner, or remove from

the premises any monument, sign ornament, fence, bridge, seat, table, tree, fountain, shrub, flower, lawn, playground equipment, pay equipment, porta johns or any other public property or buildings within or pertaining to said parks. **Do not move Porta Johns.**

PLEASE REFRAIN FROM DRIVING INTO THE PARK.

VEHICLES ARE NOT ALLOWED BEYOND THE SPLIT RAIL FENCE.

WAGONS OR CARTS ARE RECOMMENDED TO

TRANSPORT YOUR SUPPLIES TO AND FROM YOUR VEHICLES
