Ordinance No. 2025-02

AN ORDINANCE AMENDING TITLE 5 - UTILITIES;

CHAPTER 52 SEWERS; RATES AND CHARGES;

BE IT ORDAINED by the Board of Supervisors of the Dakota Dunes Community Improvement District, South Dakota, that this section be substituted in its entirety as follows:

Section 52.19. Sewer User Charges

- (A) The owner or user is required to have a water meter or in the case of a major user, a wastewater metering device for the purpose of determining the volume of metered waste. The provisions set forth in Sec. 52.23 below shall also apply. The volume of metered waste shall be measured in thousand gallons and one thousand gallons of metered water shall equal a flow unit. The volume of water measured by the water meter shall equal the metered waste for Class I and Class II users. A wastewater metering device shall be used by Class III users for determining the volume of metered waste and flow units.
- (B) The following classes of users and charges to those users are hereby established:
 - (1) Class I: Residential Users:

\$21.50 per month plus \$6.25 per thousand gallons of metered waste per month.

In addition, a surcharge of \$1.10 and a second surcharge of \$1.75 per meter per month excluding commercial and residential irrigation meters will be added

(2) Class il: Commercial/Industrial Users:

\$43.00 per month plus \$6.25 per thousand gallons of metered waste per month.

In addition, a surcharge of \$1.10 and a second surcharge of \$1.75 per meter per month excluding commercial and residential irrigation meters will be added

- (3) Class III: Major Industrial Users:
 - (a) \$43.00 per month plus \$6.25 per thousand gallons of metered waste per month(b)TSS Total Suspended Solids
