

**Ordinance No. 2025-05**  
**AN ORDINANCE ADOPTING TITLE 3 STREETS, SIDEWALKS AND PUBLIC**  
**SPACES**  
**SECTIONS 36.01 and 36.02**

**BE IT ORDAINED** by the Board of Supervisors of the Dakota Dunes Community Improvement District, that this section be adopted as follows:

**36.01 Parks and Public Spaces**

*Hours.* Except for unusual circumstances or special events approved by the District Manager, all parks and public spaces within the District shall be closed to the public every day of the year from 10:00 p.m. to 7:00 a.m.

- (A) *Park Reservations.* The District Manager may grant, upon written request, permission for exclusive use of any portion of the park for use by organized groups for the purpose of overnight camping, nature study, planned recreation programs, and other such activities as may be approved by the District Manager.
- (B) *Ejection.* The District shall have the authority to eject from the parks or reserved park area any person acting in violation of the ordinances of the District.
- (C) *Unorganized Camping.* No person shall occupy an overnight camping location within the District parks, public spaces or trails, other than as set forth above in Section 36-01(B).
- (D) *Remedies.* Any violation of the provisions of this Section 36.01 may result in the District pursuing civil remedies available to it, including but not limited to removing persons found in violation from District property.

**36.02 Trails**

(A) *Hours.* All trails in the District shall be open to the public twenty-four hours a day, seven days a week, unless otherwise restricted by curfew hours. Notwithstanding the Big Sioux Pedestrian Bridge, Big Sioux Levee Trail Gate, and the Pointe Nature Trail shall have the following hours of operation:

- (1) *Big Sioux Pedestrian Bridge.* This trail shall be closed to the public every day of the year from 11:00 p.m. to 6:00 a.m.
- (2) *Big Sioux Levee Trail Gate.* This trail gate shall be closed to the public every day of the year from 10:00 p.m. to 7:00 a.m.
- (3) *Pointe Nature Trail.* This trail shall be closed to the public every day of the year from 10:00 p.m. to 7:00 a.m.

(B) *Ejection.* The District shall have the authority to eject from its trails any person acting in violation of the ordinances of the District.

(C) *Remedies.* Any violation of the provisions of this Section 36.02 may result in the District pursuing civil remedies available to it, including but not limited to removing persons found in violation from District property.
