NJ POLYSTYRENE FOAM BAN

Beginning **May 4, 2022**, the P.L. 2020, c. 117 law prohibits all persons and food service businesses from selling/offering for sale any polystyrene foam food service product and prohibits all food service businesses from selling/providing any food served in a polystyrene foam food service product.

A "polystyrene foam food service product" is defined as a product made, in whole or in part, of polystyrene foam that is used for selling or providing a food or beverage, and includes but is not limited to a food container, plate, hot or cold beverage cup, meat or vegetable tray, cutlery, or egg carton.

"FOOD SERVICE PROVIDER"

A food service provider is any person engaged in the business of selling or distributing prepared food or beverages for on-premises or off-premises consumption. Examples of covered food service providers include:

- Restaurants
- Cafes
- Delicatessen
- Grocery Stores
- Coffee Shops
- Convenience Store
- Vending Truck
- Vending Cart
- Food Truck
- Movie Theater
- Business or Institutional Cafeteria
- Non-Profit Organization

FOAM PRODUCT EXEMPTIONS

The following products are exempt until May 4, 2024 unless otherwise extended by the DEP:

- Disposable, long-handled polystyrene foam soda spoons when required and used for thick drinks.
- Portion cups of 2 oz. or less, if used for hot foods or foods requiring lids.
- Meat and fish trays for raw or butchered meat, including poultry, or fish that is sold from a refrigerator or similar retail appliance.
- Any food product pre-packaged by the manufacturer with a polystyrene foam food service product.
- Any other polystyrene foam food service product as determined necessary by the Department (DEP).

OPERATOR EXEMPTIONS

The DEP may, upon written application by a person or food service business, waive the provisions of the polystyrene foam food service product ban for the person or food service business for a period not to exceed one year, if:

- There is no feasible and commercially available alternative for a specific polystyrene foam food service product; or
- The person or food service business has less than \$500,000 in gross annual income and there is no reasonably affordable, commercially-available alternative to the polystyrene foam food service product.

SUBMITTING WAIVERS

The Law provides an opportunity for a specific waiver to sell/use a specific polystyrene product not exempted from the ban by application to and approval from the DEP.

Applicants should provide as much detail and background information as possible to assist the Department in determining if a waiver is appropriate.

A separate application must be submitted for each product for which a waiver is requested.

Any approved waivers will be for a period not to exceed one year unless otherwise extended in writing by the Department upon receipt of a written application for extension received no less than 30 days prior to the expiration of the waiver.

FINES & ENFORCEMENT

Beginning **May 4, 2022**, any person or entity that violates the law shall be subject to:

Fines will be distributed as follows:

- A warning for a first offense.
- Up to \$1,000 per day for the second offense.
- Up to \$5,000 per day for the third and subsequent violations.
- Violations of a continuing nature constitute an additional, separate, and distinct offense for each day that is deemed a violation.

The DEP, municipalities and any entity certified pursuant to the "County Environmental Health Act" are authorized to enforce the law.
