# **Committee/Ministry Reports**

# Discernment Committee Update – Mathew Verghese, DC Co-Chair

- The Discernment Committee (DC) commenced with providing monthly updates (3<sup>rd</sup> Sunday of the month) during church services on 9/17/2023. They will provide an update on where the DC is in the Rector Search process, what has been accomplished to date, what they are currently working on, and what is still to be accomplished.
- On September 19 the Rev. Shirley Smith Graham (transition minister from the Diocese) joined the second half of the DC meeting. Important notes from this meeting:
  - The Parish Profile (now called the "Portfolio") has changed in format. It's now more structured, with questions that are filled in. This change presents a more generic, standardized document for potential applicants to review.
  - Since the format has changed, and there are now specific questions, the DC will need to address
    any questions that were not included in the parish survey. They plan to do this in town hall
    meetings, in order to get the answers that are needed to complete the Parish Portfolio.
  - Rev. Shirley may attend the town hall meetings.
- The DC Co-Chairs are working with the Treasurer and Sr. Warden to obtain the financial information that is needed for the Parish Portfolio.

# Stewardship Campaign – Jenifer Bluhm & Margot Culhane, Co-Chairs

- The next in the series of stewardship skits will be performed by Mike Gibson, Allan Steed, and David Schmidt.
- Encouraging everyone to write notes of gratitude which they can either send to someone they know or the Vestry will address and send them.
- Bobbie Johnson showed a sample of the aprons the Vestry members will wear at the brunch they will be hosting on October 22 (when the Stewardship campaign concludes).
- On October 22 "Commitment Sunday" the Vestry will lead parishioners in bringing their financial commitment up to the alter. If someone has already submitted their pledge, there will be symbolic representations which can be used. After bringing up the pledge card we will make a ripple in the baptismal font.

# Financials and Property Items

**Discussion**: LSO Request for Sale of Alcohol – Jim Tracy, Sr. Warden

Prior to the meeting Jim provided a summary of the request from the Loudoun Symphany Orchestra (LSO) to sell wine at its concerts on September 30 and October 1 of this year. Since SDECS policy requires Vestry approval for any sales or services of alcoholic beverages on the campus the matter comes before the Vestry.

• LSO has been doing concerts at St David's for a number of years. There have been no problems and they have executed and met the rental agreement each time.

- Their concerts bring an audience to St David's much of which we would not see otherwise. Their advertising provides free valuable publicity to us. Wine sales will help them continue to exist.
- The Interim Rector and the Wardens believe granting permission is in the best interests of St David's.

**Decision**: Approve LSO Request for Sale of Alcohol during their events at St. David's on September 30 and October 1, 2023.

**Motion:** In keeping with the laws of the State of Virginia and the alcohol policy of the Episcopal Diocese of Virginia, the Vestry will agree to allow the sale of wine by the Loudoun Symphony Orchestra at St. David's with its agreement that the following requirements will be followed:

- 1. LSO will obtain the required ABC license.
- 2. LSO will obtain the required liquor liability insurance.
- 3. Food will be served at the events.
- 4. Non-alcoholic beverages will also be served.
- 5. No one under the Virginia drinking age limit will be served alcohol.
- 6. Every effort must be made so anyone who has too much to drink does not drive.
- 7. Copies of the ABC license and the cover page of the liquor liability insurance will be provided to St. David's before September 28, 2023.

Motion seconded and approved.

**Discussion**: Internet Access to Annex – Jim Tracy, Sr. Warden

Prior to the meeting Jim provided background on the research into options and costs to bring suitable internet access to the Annex building. A few highlighted items:

- Option for bridge from Church to Annex We received a quote to install a bridge for approximately \$5,000, however speed was not guaranteed.
- Verizon will install 500 MB Fios at a first-year cost of \$129.00/month and a cost of \$96.00/month thereafter, since the router is paid off in the first year.
- Verizon is the most viable option and is economically attractive.

**Decision**: Approve the Verizon proposal for bringing internet to the Annex.

**Motion:** Move Vestry approve the Verizon proposal and authorize Property Administrator to proceed with the order and installation.

Motion seconded and approved.

Discussion: August 2023 Church Organization Treasurer's Report – Katherine Beckett-Goodwin, Treasurer

- Katherine provided four financial reports prior to the meeting for Vestry review, highlights of her reports are included here.
- In addition to the current reports, she is working on producing a Cash Projection report to better represent cash flow.
- Pledge income is at 96% of budget YTD as of Aug.
- Pledge income for August was \$15K above budget projection. This may be due to catch up contributions.
- 2023 Church Operating Expenses are more than Operating Income as of 8/31/2023. (Repairs)
- The additional ~\$20K in HVAC expenses is still under review by insurance (has been submitted).
- Liquidity is good with operating cash at ~\$221K [includes Employee Retention Credit (ERC) net of ~\$122K].

## Draft

- Some Repair Reserve and Capital Fund transfers for approved expenses by the Vestry have not yet been made, which will increase church operating cash.
- Highlights from the Finance Committee (FC) Meeting:
  - Jim Tracy is chair of the 2024 Church Operating Budget Committee. Members: Katherine Becket-Goodwin (Treasurer), Mike Gibson (Vestry Member), David Halstead (CPA).
  - Reviewing investment funds for FC recommendation to the Vestry for October meeting.
  - Reviewing financial reports to be more representative of St. David's overall financial standing such
    as how reserve funds are reflected, cash projection to help with planning, etc.
  - Need to discuss how to allocate the ERC rebate. 1) School portion, 2) consider options such as apply it to church operating income (where it is now), pay for delayed maintenance, save to Capital or RR funds.

**Decision**: Approve August 2023 Church Organization Treasurer's Report

**Motion:** Move to approve August 2023 Church Organization Treasurer's Report as presented. Motion seconded and approved.

# Marketing & Advertising – Margot Culhane

- Margot and Jim Tracy discussed some ideas for lower cost, higher impact local marketing opportunities.
- Looking at home owners' associations' newsletters at a few communities in the area (Belmont Country Club, Lansdowne and Ashburn Village). Will add in other neighborhoods later such as Ashburn Farms, Potomac Green, and Broadlands.
- For a total of \$1,300 we can reach around 10,000 households.
- Goal is to get advertisements in the December newsletter issues.
- Looked at Loudoun Times Mirror, but this is a weekly commitment and gets expensive.
- Also looked at direct mailing of postcards but the cost is higher (approx. \$5,000) and the reach is smaller than the neighborhood newsletters.

## **Mission and Vision**

**Discussion**: Mission/Outreach Committee Report – Margot Culhane and Mike Gibson, Co-chairs A report was distributed prior to the meeting for review.

- Mike reported that there will be an opportunity for financial support for outreach from the proceeds from the Men's Group dues, which have been reinstated.
- As always, the Men's Group is also available to support St. David's Outreach.
- Jim reported that the Bromley Mission Ministry recently sent \$15,000 to support the Bromley Electrification Project. It would be good to publicize this outreach on the St. David's website so that we can get the word out to the St. David's congregation and hopefully even broader outside of St. David's about our international outreach that continues Margaret Mercer's legacy.
- This year we can be a collection point for Toys for Tots. They also need help with pick-ups and delivery.
- Considering participating in the Cops and Kids Coat Drive again this year. Reach out to contact for details.

  - Recognize that we are leaders of the church and serve as models for the rest of the congregation
  - Encourage and support each other (other vestry members)
  - "Share what's on your mind with respect" adding: "and respect what others share"
  - Address topics in the appropriate forum. Bring issues to meetings (rather than having side conversations).
- Susan+ reported she plans to put headshots out of all Vestry members so parishioners are aware of who their Vestry members are. She will also include minutes from the Vestry meetings in this location with the photos.

# Wardens' Report – Jim Tracy, Sr. Warden and Jenifer Bluhm, Jr. Warden

The Wardens presented the report to the Vestry prior to the meeting, highlights of the report include:

- Stewardship is underway This is the first year we have been able to offer Text-to-Give. It is a function of Realm and Ginny has implemented it for us.
- Parishioner mailing list/database Urgency of updated database of parishioners brought forward. The committee with Margot's leadership is working on this with help from staff and Vestry.
- Chairs for Stewardship fall campaign has been run by a Vestry member for 3 consecutive years and by Rev. Mary Kay Brown a prior year due to COVID-19 pandemic. This function is not required to be Vestryled. We should begin cultivating people who may be called to this role, and we should maintain a Vestry liaison, and a knowledgeable office staff person to assist in the continuity from year to year.

- Eagle Project Carly Hanlin completed her Eagle project which included documenting the Belmont Chapel graves and registering them in the MillionGraves.org website, as well as creating signage for the graveyard. The sign was dedicated at the Back to Church Sunday & Margaret Mercer Day Service 9/17/2023.
- Trustees of the Funds (TOTF) Jim Tracy has been following the news releases from TOTF regarding the cyber theft last December. The revelation that another theft had occurred but had not been discovered raises concerns. The Finance Committee, Sr. Warden, and Treasurer will evaluate next steps in regard to St. David's investment fund assets and bring a recommendation to the Vestry next month.
- Realm training Several office staff will participate in Realm Training this week. 9/20-9/21.
