



**ATTENTION TRAINERS / OWNERS:** By submitting this application, each trainer/owner will be responsible for the condition of his or her stalls hay sheds and tack rooms upon leaving. Trainer/Owner agrees to pay a cleaning/disposal fee of \$100.00 per stall and \$500.00 per tack room at time of departure if stalls and/or tack rooms are not left clean of all muck, bedding and trash at the time of their final SunRay Park & Casino departure. A cleaning/disposal fee may be charged for any appliance that is left on SunRay Park & Casino property that includes, but is not limited to, refrigerators, washing machines, stoves, dryers, or microwaves. All stalls and tack rooms must be cleaned prior to receiving registration papers upon final departure from SunRay Park & Casino. Non-Compliance with this stall and tack room cleaning/disposal policy will prevent trainer/owner from receiving any future stall assignment at SunRay Park & Casino until and unless all stall and tack room cleaning fees, including interest and or penalties, as determined by SunRay Park & Casino management are paid in full. Straw will not be allowed for use as bedding. SAWDUST ONLY. No children are permitted to reside in the barn area. Clean material must be used on walker rings. The trainer/owner of horse(s) that are euthanized, that is not track related will be charged a removal and disposal fee of \$65.00/horse.

POLICIES for the 2026 SUNRAY PARK & CASINO race meet as adopted by the New Mexico State Racing Commission:

1. If the Trainer has not bedded assigned stalls or made arrangements with management to show intent of occupying stalls, the stalls will be reassigned after the first entry day.
2. Screening rules will be approved by each individual track's local committee and must be approved by the Racing Commission.
3. All horses must have a Health Certificate. Thoroughbreds must have current Coggins. Quarter horses must have CURRENT Negative Coggins & Piroplasmosis. Coggins must have been issued within the previous 12 months, & piroplasmosis (24) months & must be presented at the stable gate upon arrival.
4. IN slips and OUT slips will be required on all horses.
5. Access to the Sunray Park & Casino barn area and racetrack shall be restricted until all written consents are received permitting the simulcast export of the 2026 Sunray Park & Casino race meet under the Interstate Horse Racing Act of 1978.
6. Allocation and assignment of stalls at SunRay Park & Casino will be determined by management based on a review, analysis and determination of the quality of past performances at SunRay Park & Casino or at other racetracks as supplied with application. Preference will be given to New Mexico Bred horses over other horses of comparable quality and performance statistics on each application.
7. All applications will include past performances of all horses and a copy of the trainers current license.
8. Trainers placing horses in stalls other than those specifically assigned to them will be subject to a fine and removal of excess horses from the grounds. Any trainer assigned less than ten stalls, will not necessarily be assigned a pony stall or walker space.
9. Poor performance standards will be enforced at the current meet for a horse who runs at the bottom claiming price in their last four (4) starts and does not place first, second, third, or fourth at the discretion of the Racing Secretary and Stewards.
10. Stalls assigned to a trainer or owner will be determined by SunRay Park & Casino Management.
11. The Track will be closed every Monday, throughout the race meet.
12. A \$100 PER STALL FEE AND \$500 PER TACK ROOM WILL BE IMPOSED ON ANY TRAINER WHO LEAVES THEIR STALLS/ TACK ROOM UNCLEANED.
13. BARN AREA OPENS Saturday, April 4, 2026. TRACK OPENS Monday, April 6, 2026.

**In applying for stalls: it is to your benefit to have your application submitted to SUNRAY PARK on or before the Monday, March 2, 2026 deadline complete with all information requested and your signature. Stall applications that are late, incomplete, or unsigned may result in your stabling request being denied. No Exceptions.**

**ELIGIBILITY DOES NOT MEAN APPROVAL. All horses may be subject to pre-race inspection.**

The Daily Racing Form and Daily Racing Chart Book and The American Quarter Horse Association Chart Book shall be the determining publications in establishing eligibility.

**Eligibility Rules:**

1. Any horse placed on the poor performance list during the meet will be ineligible to start and must be removed from the grounds. Minimum claiming price \$5,000.
2. Two year olds not nominated to a futurity or stakes, at SunRay, and are not New Mexico Bred, will receive least preference. Payment of any nomination, eligibility, or other entry fee, for any stake, shall not entitle a horse to stabling.

**PREFERENCE:**

In granting stalls to a stable, consideration will be given to stables with a **balanced application**. SUNRAY PARK & CASINO reserves the right to approve all horses. Horses, which in the opinion of the management of SunRay Park are not of a caliber suitable to the racing program to be offered at SunRay Park & Casino, will not be approved for stalls.

**This is not a lease of space but an agreement to the terms outlined below:**

The undersigned as a part of this application for stabling of any or all of the horses listed herein at SunRay Park & Casino for the 2026 racing season agrees to the following terms and conditions: 1. SunRay Park & Casino reserves the right to refuse this application for stable space in whole or in part, or to refuse the acceptance of any entry in any race for any reason or cause and without notice to the undersigned. 2. (A) Abide by all the rules of SunRay Park & Casino pertaining to stabling. (B) To vacate the stalls and move any or all horses, vehicles, equipment and personnel off the premises of SunRay Park & Casino within three days after requested to do so. (C) That SunRay Park & Casino, its agents or employees, will not be liable or responsible for any injury or loss suffered in any manner by or to the horses, vehicles, equipment, personnel, friends, relatives or agents of the undersigned while on or off the premises or while being transported in any manner on or off the premises irrespective of the cause or reason for such injury or loss. (D) That the undersigned releases SunRay Park & Casino, its agents and employees, from and against all claims of such injury or loss by or on behalf of the undersigned. (E) To hold SunRay Park & Casino, its agents and employees, free and harmless from all losses, damage, liability or expense, including attorney's fees; due to or arising out of the stabling and/or action of horses, other animals, equipment or vehicles of or in charge of the undersigned at SunRay Park & Casino or by reason of any conduct or negligence of the undersigned or any of his employees or agents. 3. No stabling will be permitted, and no entry in any race will be received except upon conditions that all disputes, claims and objections arising out of the racing or with respect to the interpretation of any rules or conditions or races otherwise shall be decided by the State Racing Commission of New Mexico, the stewards of the meeting or SunRay Park & Casino as the case may be, and such decisions upon all points shall be final. 4. Payment of any nomination, eligibility or other entry fee for any stake shall not entitle or guarantee a horse to stabling at SunRay Park & Casino. 5. SunRay Park & Casino may desire to use television or radio directly or by photographic transcription all or some of the races, and reserves all rights to reproduce such races directly by television or any other media. Entries will be accepted only on the condition that if requested by SunRay Park, the owner, the jockey, the trainer, the groom and all other employees of the owner coming within the view of the television picture sign and deliver to SunRay Park & Casino, releases, permitting such television and the exhibition thereof directly or indirectly. 6. The signer represents that he/she and all persons for whom he/she are acting, have read or will familiarize themselves with the Rules of Racing and the regulations of the State Racing Commission of New Mexico and the horse race officials, and agrees that all animals shall be subject to the same, and the acts and decisions of the race officials. 7. All horses whose stall applications are accepted are subject to Veterinarian's examination. By submitting this application (nomination) owner and trainer hereby appoint the track veterinarian the owner and trainers' lawful attorney-in-fact in the track veterinarian's sole discretion to euthanize any horse owned by owner or trained by trainer, which may "breakdown" on the premises of the licensee. 8. SunRay Park & Casino Management reserves the right to expel any or all horses that are not entered at least once every 30 days. 9. The undersigned "Applicant" understands and agrees that he or she will be financially responsible for any and all damages to SunRay Park & Casino property used or assigned to them that occur or result from the behavior, actions or negligence of themselves, their invited friends or relatives, employees, personnel, agents, horses, animals, vehicles and equipment regardless of reason. 10. It is all Trainers responsibility to vacate SunRay Parks Property no more, than 4 days (96 hours) after the last day of the 2026 Race meet, unless notified otherwise. 11. The undersigned represents that he/she has the right to make the above representations and agreements with respect to every owner of every horse listed herein, and that each owner will be bound hereby.

**The trainer signing this application represents that he is authorized by each owner listed on this application to sign this application and further, that he has signed this application on behalf of each such owner. By signing and submitting this Stall Application, the undersigned does hereby appoint the SunRay Park Horsemen's Committee to act as its sole and exclusive representative for the purposes of negotiating and executing, or refusing to execute with the SunRay Park any and all contracts and agreements relating to horse racing at SunRay Park during the subject racing meeting and, I hereby revoke any previous authorizations or recognitions that are in conflict with the foregoing.**

**SUNRAY PARK & CASINO MAKES NO REPRESENTATION OR WARRANTY AS TO THE CONDITION, USE OR OPERATION OF STABLE FACILITIES AND OCCUPANCY OF SUCH FACILITIES BY THE TRAINER AND HIS HORSES AND EMPLOYEES SHALL CONCLUSIVELY ESTABLISH THAT SUCH FACILITIES ARE IN SATISFACTORY AND ACCEPTABLE CONDITION, ORDER AND REPAIR.
