## Rules for Entry

- There is no entry fee for dolls and no limit to the number of entries. Each entry must have a separate entry form.
- The number of dolls accepted from each artist will be determined by how many dolls are entered in total.
- All entries must be finished to be considered. Do Not submit photos of works in progress.
- Entries from previous Best of the Valley shows are excluded
- Dolls must be primarily made of cloth.
- If accepted, dolls must be clean, odor-free, dust free and ready to display.
- This is a juried and invitational show. Submission of entry does not guarantee acceptance.
- All decisions of the jury will be final.
- If accepted, be sure to put your name on the doll and on each prop that accompanies the doll.

## Photograph Instructions

- Submit a color photo of the doll with each entry. Computer generated photos will be accepted. 5"W x 8"H photos are preferred. Put doll name and your name on the front of the photo.
