

LIMITED WARRANTY TERMS AND CONDITIONS FOR ELECTRIC VEHICLES

Kodiak EV warrants that any new Kodiak EV purchased from Cart Part Pros, or any Authorized Dealer will be free from defects in material and workmanship for two years from the date of purchase, subject to the limitations stated below. During the term of the two-year warranty, and authorized KODIAK EV service technician or KODIAK EV dealer will, free of charge, repair or replace (at KODIAK EV option) any part determined to be defective by KODIAK EV due to faulty workmanship or material from the factory. Parts used in warranty repairs will be warranted for the balance of the vehicle's warranty period. All parts replaced under warranty become property of KODIAK EV.

Items Excluded from the Warranty:

Routine maintenance items, normal wear and tear, cosmetic deterioration, or electrical components damaged as a result of fluctuations in electrical current

Damage to or deterioration of the cart resulting from inadequate maintenance, neglect, abuse, accident or collision.

Damage resulting from installation or use of parts and accessories not approved by KODIAK EV

Warranty claims must be made and honored by KODIAK EV or an authorized KODIAK EV dealership

Damage or loss resulting from acts of nature, weather events, theft, vandalism or other circumstances in which KODIAK EV has no control

Any and all expenses incurred in transporting the cart to and from KODIAK EV or an authorized dealer for warranty service.

LIABILITY LIMITATIONS:

In no case shall KODIAK EV be liable for indirect, incidental, special, punitive or consequential damage, including but not limited to death, personal injury or property damage arising from or related to any alleged failure in a cart or battery charger or any damage or loss to the purchaser or any third party lost time, inconvenience or any economic loss, whether or not KODIAK EV was apprised of the foreseeability to such damage or losses. The right of the purchaser to recover damages within the limitations set forth in this section purchaser's exclusive alternative remedy if the limited remedy of repair or replacement of the vehicle fails of its essential purpose. Any legal claim or action arising that alleges breach of warranty must be brough within three months from the date the warranty claim arises.

WARNING:

Any modification or change to the vehicle, battery, and battery charger which alter the weight distribution or stability of the vehicle, increases the cart's speed, or alter the output of the battery charger beyond factory specifications can result in property damage, personal injury death. Do not make any such modifications or changes or they will void the limited warranty. KODIAK EV disclaims responsibility for any such modifications, changes, or such altercations that would adversely impact the safe operation of the vehicle or battery charger.
