

#### Properties, Building & Manse

2023 was a year with no major expenses incurred; just normal maintenance as follows: -number of jobs were completed at the manse; new faucets were installed in the upstairs bathroom and kitchen. Also new sink for kitchen installed. Downstairs bathroom toilet had new ports installed to stop it from leaking. Two natural gas leaks were discovered in the basement and repaired. Window a/c unit purchased for manse.

-Church sanctuary has had a number of light bulbs replaced with LED bulbs purchased by Bob Mickleborough. This work completed by Cliff Warren. The lift door was repaired by Access 2000.

-Sink and toilet in ladies washroom repaired with new parts; C.E. steps repaired and painted

-Discovered that our lack of heat in the secretary and minister's office was because of the heat pipes in the crawl space have rusted away. With a little ingenuity the existing pipes have been temporarily repaired so heat is now reaching those areas and not just the crawl space. Also large cracks in the foundation were repaired to stop cold air coming in.

#### Stewardship Report

The budget presented by the board for 2023 included revenues and expenditures of \$124,075.00. Our actual revenues were \$126,567.07 and expenditures were \$126,674.02 for a year-end budget deficit of \$106.95. Although, we have held back our National Assessment fee to the United Church of Canada in the amount of \$5,756.00. Your continued support coupled with very successful fundraisers of our Spring Lasagna take-out supper and our take-out Fall Supper & on-line Auction allowed us to have a minimal budget deficit.

We have presented a 2024 deficit budget of \$548.00 to the board including revenues of \$134,850.00 and expenses of \$135,398.00. We continue to be challenged by rising expenses and will require your continuing support for fundraising activities and local giving.

Full time ministry for our congregation has provided more visitation time and community involvement for our minister. We are confident the membership will continue to support our full time ministry.

Your donations to Mission & Service for 2023 were \$4,090.00, exceeding our goal slightly. Thank you. Please keep Mission & Service a priority, as it does so much for worthy causes.

We would also like to recognize and thank Dianne Anderson for her continuing faithful service to our congregation and board.

Thank you for your continuing support of the programs and ministry of St. Andrew's.
