Our annual basic SWAT school, "Hell Week", has become one of the most prominent SWAT schools in the Western United States. I serve as a planner and lead instructor in that school. I have served as a trainer and advisor in the formation of SWAT teams in Grand, Kane, Carbon, Emery and San Juan Counties in Utah. I and a fellow SWAT commander have assisted and advised the Utah State Board of Education in the formation of an active shooter training scenario. We have currently held training scenarios for Washington, Summit and Grand School Districts.
