



## Consignment Agreement

Between: The Barn on the Ridge (“Consignee”)

and

[Consignor Name] (“Consignor”)

### 1. Purpose of Agreement

The purpose of this Agreement is to set out the terms under which The Barn on the Ridge will offer for sale the Consignor’s wedding items (including but not limited to wedding dresses, décor, accessories, and styling pieces) on a consignment basis at its pop-up shop or other designated sales venues.

### 2. Items on Consignment

The Consignor agrees to deliver to the Consignee the items listed in Schedule A (attached) for display and sale on their behalf. The Consignee reserves the right to refuse any items deemed unsuitable for sale due to condition, style, or quality.

### 3. Consignment Fee and Payment

1. The Consignee will retain a 20% commission on the final sale price of each item sold (the “Consignment Fee”).
2. The remaining 80% will be paid to the Consignor within 14 business days after the item’s sale, via bank transfer or another agreed payment method.
3. The Consignee’s fee covers display, marketing, customer service, point-of-sale handling, and transaction processing.
4. All sale prices will be mutually agreed upon before display.

### 4. Term of Consignment

1. Items will remain on consignment for a period of [e.g. 60 days] from the date of delivery, unless otherwise agreed.
2. Unsold items must be collected by the Consignor within 7 days of the end of the consignment period. Items not collected within this period may be donated or disposed of at the Consignee’s discretion.



## **5. Condition of Items**

1. All items must be clean, free from damage, and ready for sale.
2. The Consignee is not responsible for cleaning, repair, or restoration of items unless agreed in writing.

## **6. Liability and Risk**

1. While reasonable care will be taken to protect items on consignment, The Barn on the Ridge accepts no liability for loss, theft, damage, fire, water damage, or any other incident beyond its control.
2. The Consignor acknowledges and agrees that all items are left at their own risk.
3. The Consignee does not provide insurance for consigned items, and the Consignor is encouraged to maintain their own insurance coverage.

## **7. Pricing and Discounts**

1. The Consignee will sell the items at the agreed price unless the Consignor provides written consent to adjust the pricing or apply discounts.
2. From time to time, the Consignee may host promotional sales or events. Participation in such promotions will be at the Consignor's discretion.

## **8. Photography and Promotion Consent**

1. The Consignor grants The Barn on the Ridge permission to photograph, video, or otherwise record their consigned items for the purpose of marketing, social media promotion, advertising, or display (both online and offline).
2. The Consignee may use these images across websites, social media platforms, print materials, and other promotional channels, without further notice or compensation to the Consignor.
3. The Consignee agrees that all photography will be used tastefully and in a manner consistent with promoting wedding-related products and services.
4. The Consignor may revoke this consent in writing at any time; however, this will not affect images already used or published prior to revocation.

## **9. Sales Updates and Communication**

1. The Consignee will provide a sales update to all consignors once per week, summarising items sold and any relevant account balances.
2. Individual messages or inquiries regarding sales status will not be answered outside of these scheduled updates, to ensure fairness and consistency for all consignors.



3. Any urgent matters (such as withdrawal of items or contact details changes) may still be communicated directly in writing to the Consignee.

### **10. Ownership and Title**

Ownership of the items remains with the Consignor until sold. Upon sale, title passes directly from the Consignor to the purchaser.

### **11. Termination**

Either party may terminate this Agreement at any time with written notice. Upon termination, the Consignor must collect all remaining items within 7 days, after which the Consignee may dispose of or donate them without further liability.

### **12. Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of [Your State], Australia.

### **13. Entire Agreement**

This Agreement constitutes the entire understanding between the parties and supersedes all prior discussions, arrangements, or agreements.
