MARY, QUEEN OF PEACE CATHOLIC CHURCH SKYLINE HIGH SCHOOL STUDENT PARKING REGULATIONS

What is Student Parking?

Mary, Queen of Peace (MQP) offers Skyline High School students the opportunity to park in our parking lot during the school year. We offer parking permits for each semester of the school year and an assigned parking stall. Parking permits are limited and available on a first-come, first-served basis, with priority given to MQP parishioners. *All Skyline High School students are welcome to apply.*

Skyline students, who wish to park at MQP for school commuting purposes, must apply in person for an MQP Student Parking Permit. **Applications will not be accepted if the *driving Student* is not present at time of application.**

Students may begin submitting applications in the MQP Parish Office on the following schedule:

MQP Parishioners: Monday thru Friday 11am to 2pm, 8/4 thru 8/8 & 8/11 thru 8/15.

All other Students: Monday thru Friday 11am to 2pm, 8/25 thru 8/29 & 9/1 thru 9/5.

Please note that the Parking Lot will be resealed and painted from 8/18 thru 8/22.

The Church and offices will be closed and will be inaccessible.

Students whose families are active registered parishioners of MQP will receive priority consideration for a parking. After that, all stalls will be assigned on a first-come, first-served basis. Permits are limited.

All required information and supporting documents must be submitted with the application. Please see attached Supporting Document Checklist.

MQP STUDENT PARKING POLICIES:

- Student must maintain *current* information on file with MQP. Changes must be submitted, *in writing within one week*, to the MQP Parish Office (i.e., change of vehicle; change in personal information or insurance provider).
- Each Permit assigns a specific vehicle to a specific parking stall. Students may not share their Parking Permit with another student. Any vehicle changes must be communicated to the MQP Parish Office.
- Parking Permit grants students the privilege to park in the MQP parking lot in the *student parking area* (see map—available in the MQP Parish Office) during school hours.
- MQP Student Parking Permit *must be placed on the lower left side of the front windshield* of the vehicle. If it is not clearly visible, a fine may be issued. Repeat violators may have their car towed at the owner's expense and forfeiture of parking privileges.
- Lost permits may be replaced for \$10. A lost permit must be reported to the MQP Parish Office without delay.
- If the license number, make, and model of the vehicle does not match the license number associated with permit, a fine may be issued. Repeat violators may have their car towed at the owner's expense and forfeiture of parking privileges.
- Students may park only in their assigned parking stall. Parking anywhere else on the MQP lot may result in a fine and having their car towed. Repeat violations will result in the forfeiture of parking privileges at the church and the student may become ineligible for parking on the MQP campus for the remainder of their time at Skyline High School.
- Students assume responsibility for keeping the area around their vehicle clean. Any paper, restaurant or food debris found near their vehicle may result in fines, towing at the vehicle owner's expense, and even closing of the entire parking lot for one week per incident. It is the responsibility of all student parkers to maintain the cleanliness of the student parking area.



- Students are forbidden from bringing any illegal substances or stolen items onto MQP property.
- MQP Staff are neither qualified nor trained to assist students in gaining access to their car or in its maintenance.
- MQP reserves the right to temporarily suspend parking privileges when a church event requires full use of the parking lot. Should such an occasion arise, MQP will either place a written notice on the windshield of student vehicles in advance or send an email.

DRIVING ON OR ABOUT MARY, QUEEN OF PEACE PROPERTY:

- Observe and obey all Washington State and local traffic laws; failure to do so may result in immediate revocation of the MQP Student Parking Permit.
- The speed limit in the church parking lot is **10 MPH** and will be strictly enforced.
- Observe and obey all entrance, exit, and directional markings.
- Speeding, reckless driving, or endangerment in the MQP parking lot or on adjacent streets may result in revocation of the MQP Parking Permit and citation by local law enforcement authorities.
- Violations may result in a fine, revocation of parking permit, and/or towing of vehicle at the owner's expense.

THESE POLICIES SERVE AS WRITTEN WARNING FOR ALL STUDENT PARKERS. NO SUBSEQUENT WARNINGS SHOULD BE EXPECTED. FINES BEGIN AT \$25.00, PAYABLE TO THE MQP PARISH OFFICE, AND INCREASE WITH EACH SUBSEQUENT VIOLATION (\$50, \$100, \$200, ETC.). VIOLATIONS MAY ALSO RESULT IN TOWING AT VEHICLE OWNER'S EXPENSE.

CONSEQUENCES OF MISUSE OR ABUSE OF MQP PARKING PRIVILEGES:

The consequences for violating the rules established by this agreement include:

- fines
- the revocation of your parking permit
- revocation of any future parking privileges at either Mary, Queen of Peace or Skyline High School
- towing of your vehicle at your expense
- citation issued by the Sammamish Police Department.

The undersigned parent/legal guardian intends his or her signature to be a complete and unconditional release of all liability to the greatest extent allowed by law. If any portion of the Release is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
