PARTICIPANT WAIVER AND RELEASE OF LIABILITY

Please read this document carefully before completing your registration. By signing below, you confirm that you have read and understood its terms on behalf of yourself and the minor participant(s) in your care.

1. About the Activity

Gameday Youth Basketball ("Gameday") is a youth basketball league operated by Metro Prep League, LLC, doing business as Gameday, located near Hwy 380 and FM 423, Frisco, Texas. Activities include but are not limited to team practices, scheduled games, warm-ups, and any related league programming on or off the facility premises.

2. Acknowledgment of Risk

I understand that basketball and physical activity involve inherent risks, including the risk of bodily injury. These risks include but are not limited to sprains, fractures, concussions, and other physical injuries that may result from player contact, falls, or the physical demands of the sport. I voluntarily accept these risks on behalf of the participant.

3. Release of Liability

In consideration of the participant's involvement in Gameday activities, I, on behalf of myself, the participant, and our heirs, executors, and assigns, hereby release and discharge Metro Prep League, LLC, doing business as Gameday Youth Basketball, their officers, employees, volunteers, referees, coaches, and agents (collectively, "Gameday") from any and all claims, damages, losses, or expenses, including medical expenses, arising out of or in connection with the participant's involvement in league activities, whether caused by negligence or otherwise, to the fullest extent permitted by applicable law.

4. Medical Authorization

I authorize Gameday staff to seek emergency medical treatment for the participant if I cannot be reached in a timely manner. I accept financial responsibility for any medical expenses incurred. I confirm that the participant is physically capable of participating in the activities described above and is not subject to any medical restriction that would prevent safe participation.

5. Code of Conduct

I agree to conduct myself in a manner consistent with Gameday's standards of sportsmanship and respect. I understand that abusive, threatening, or disruptive behavior toward players, coaches, referees, or staff may result in removal from the facility and forfeiture of registration fees. These standards apply equally to participants, parents, and coaches.

6. Media Release

Participation in Gameday Youth Basketball constitutes consent for the use of photographs and video captured during league activities for use on Gameday's social media pages, website, and promotional materials.
