



## **Certificate in Planning Enforcement**

**We have 3 intakes running:**

**September 2025, May 2026 & September 2027 (dates on last page)**

The course is aimed at both new and more seasoned planning enforcement officers and aims to provide a thorough grounding in the legal and practical aspects of planning enforcement.

The course provides officers with a thorough grounding in the principles behind their planning enforcement powers and, through case studies and small group work, examples of the exercise of those powers in practice and the pitfalls and strategies which can be employed.

Training involves a mixture of taught (online) classes, case studies and small group work and we aim to make the training days as intensive and immersive as possible.

The Certificate in Planning Enforcement consists of **4 modules** and can be completed consecutively or, exceptionally, out of order. Each module takes **4 months** to complete, and the certificate duration is **16 months**.

The structure for all 4 modules each consists of

- A self-study component
- Completion of a quiz
- Attendance of two on-line training days
- Submission of an essay
