This year has been shaped by both challenge and achievement. Ros, who has continued to lead the organisation with great strength while recovering from significant surgery, has provided steady direction and vision. Paddy and Dan have carried an enormous workload, turning out high-quality work at an impressive pace. As a committee, we are proud of the resilience and commitment shown by our small but mighty team.

Our committee is made up of committed CNA members from across the country. While most of our work happens online, we make every effort to come together in person when we can, to connect and to support the team. This mix of local knowledge and national perspective keeps us grounded in the realities of the sector, while ensuring CNA has strong governance with connections across the country.

From a governance perspective, our focus has been on strengthening CNA's role as a sector leader and ensuring our work continues to deliver value for members.

Some highlights include:

- Exploring technology solutions to ease compliance pressures for Tier 3 and 4 organisations, including a potential app.
- Marking CNA's 50th anniversary, celebrating our history and reaffirming our relevance.
- Seeing over 1,000 people complete Tick for Governance training, strengthening boards across the motu.

- Preparing for the 2027 State of the Sector Survey, to launch in February, which will give us vital data for advocacy.
- Exploring the opportunity to host an election panel with Sue Barker in February (to be confirmed), ensuring the sector's voice is part of national conversations.

We are grateful for the ongoing support of MSD, JR McKenzie Trust, and Lotteries, whose funding enables us to continue this work.

As a committee, we are proud of the direction CNA is heading in and grateful for the trust of our members. Our role is to provide good governance, ensure accountability, and back the incredible mahi of our team. Together, we are building on 50 years of history to ensure a strong, connected, and resilient community sector for the future.

Starting back at work in January of this year following my illness, I rapidly needed to come back up to speed as the organisation was forging ahead with incredible and fantastic projects. Rather than repeat what Holly and Chris put in their reports I want to cover in this report.

Staff work; new projects on the go; collaborations and the future.

Staff Work I can't begin to describe my great fortune in working with two of the hardest working blokes I have met. Patrick simply never stops. He actually relishes deadlines, events, and to this day I haven't been able to decipher his filing system, but that's ok, he tells me where to find stuff.

Dan is the man with the colour, design and PR knowledge that churns out our newsletters, our PR projects, and plans for our years social media and our research designs. He has become a part of our small CNA family, and his sister Lydia also works for us, from Spain. They are quite the duo, and we are mighty glad they are with us sharing day to day lives. Collaborations This past year has been full of collaborations for CNA .

Starting with working with other NGOs to fight the proposed taxes on NGOs. Make no mistake the issue of the IRD trying to tax care is not over yet.

We have been regularly collaborating with Pointsbuild who are the platform for the Tick for Governance on-line training. We work with them to update when there is new legislation or to update some of the things in the course. This regular collaboration takes place several times a year. We have been collaborating with Steven Moe and Louisa Joblin and Sue Barker when doing our on-line zooms on different subjects. These three lawyers are very generous with their time and donate time to us when appropriate. (Steven is also our organisation's lawyer.)

We are working on a collaboration with WiseComply to develop a compliance app that organisations can use for organisation management, with a compliance dashboard and reminders alongside guided workflows for registration updates, annual returns and rule changes. We hope this inexpensive app will greatly aid our governance boards and staff to keep up with the ever-increasing compliance requirements we are all currently facing.

We enjoy being part of the Constellation. This group of multiple Wellington NGOs and some regional networks is working together on several projects, and we like being able to work together with these other non-profit bodies.

We also work collaboratively with Brett Jeffries from NZSAE which is the New Zealand Society of Association Executives. When issues come up like legislations changes, for example. Brett calls together staff association members to combine skills and thoughts for submissions and ideas. We are always part of these think tanks and the sharing of information and advice from senior executives in multiple organisations is invaluable to us.

We have just finished our celebrations for our 50th year as an organisation. We are already looking toward our 2026 Conference, and this year we are very hopeful that this next conference will be a collaboration between us and another large Wellington non-profit. Watch this space.

The Future

2026 will be my last year as Executive Officer of CNA. After 19 years in this job, I think it is not only time for me to slow down, but also time for new eyes on CNA from the EO view.

With a new EO in 2027 and with input from some new Board members, the future is bright and exciting. I hope you will be there to share our changes with you.

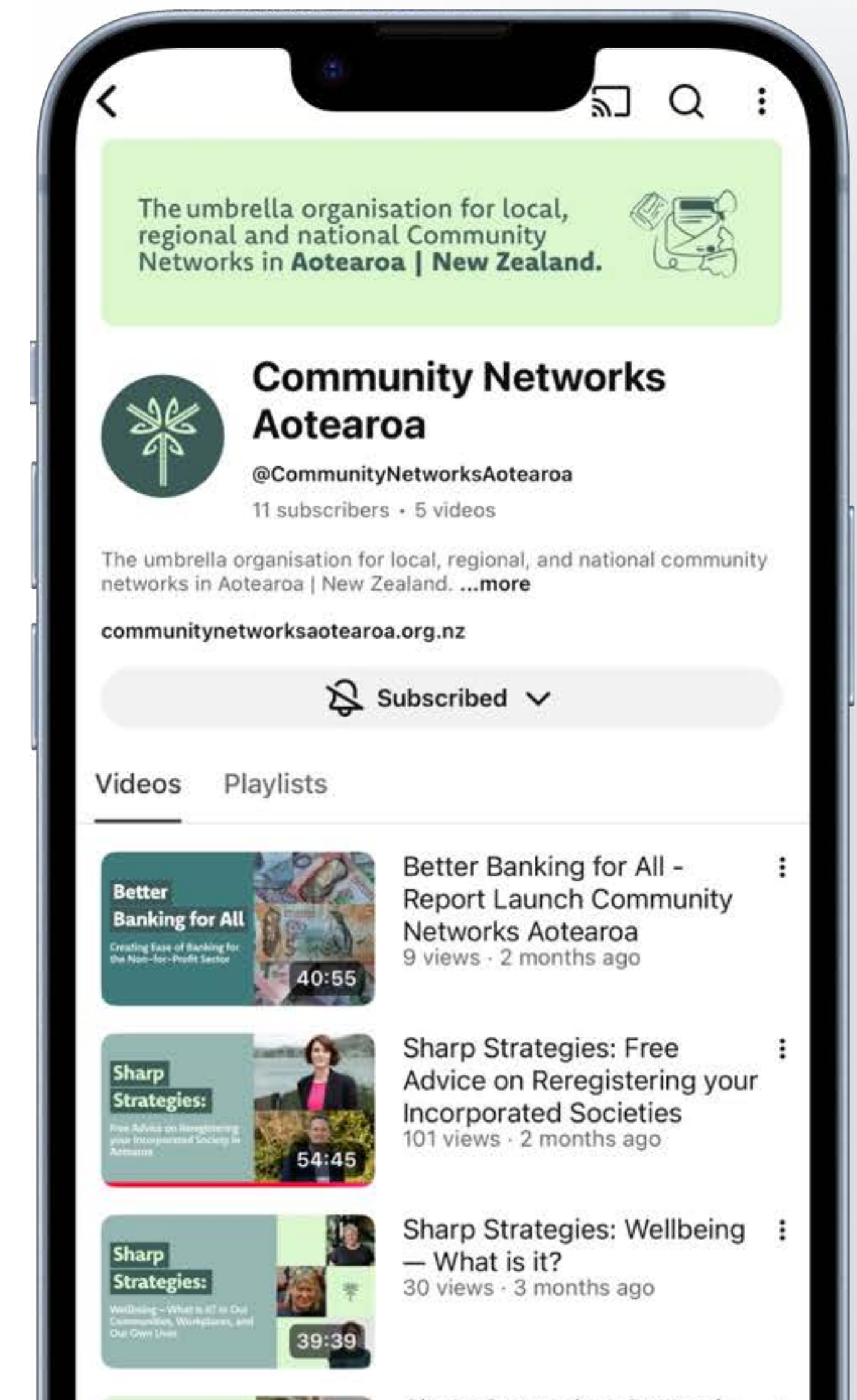

Engagement: Neighbourly Natters

In recognition that CNA has expanded its membership greatly in the last couple of years we have begun our 'Neighbourly Natters'. Getting our Members within each region to have a quick meet and greet. Some are old friends already and some are new, so it was great to see connections being made and new friendships with possible collaborators being forged.

Our 2025 season was specifically for Members only; and we have had numerous enquiries as to if we'll be widening the catchment next year.

It is important to CNA that we don't replicate the wheel but add to the journey. In 2026 we'll deepen our members connections and continue to strengthen ties between new friends and old mates in our Sector.



Representation: Select Committees

CNA continues to step up to be the voice of our Members and the wider Sector by ensuring our concerns are heard as legislation is debated. It may be visits to Ministers, MPs, and to Opposition Parties' members; and it can also be by advocating for our whanau in Select Committees:

Online Casino Gambling Bill:

CNA supports the Bill's intent to regulate currently unregulated online casino gambling and to reduce gambling harm. However, we are deeply concerned that the Bill, as currently drafted, omits a critical principle that has long underpinned public acceptance of gambling in New Zealand: the obligation to return a share of gambling proceeds to the community. Without this safeguard, the Bill risks weakening the social contract that justifies gambling's legal status—and further eroding the already-declining funding available to community, cultural, sporting, environmental, and social service organisations.

Anti Money Laundering & Countering the Financing of Terrorism Amendment Bill:

This submission responds to the Anti-Money Laundering and Countering the Financing of Terrorism Amendment Bill, advocating for proportionate compliance measures for small charities and community organisations. It emphasises minimising unintended burdens, protecting civil society space, and ensuring consultation with the sector in designing and implementing AML/CFT regulations.

Taxation and the Not-For-Profit Sector:

Community Networks Aotearoa's submission in response to the government's discussion paper on Not-for-Profit taxation highlights sector concerns about proposed changes. It calls for a more equitable, informed approach that recognises the diverse nature and value of NFPs, and advocates for policies that support their ongoing contribution to communities across Aotearoa.

Sector Projects:

Better Banking for Non-for-Profits

We continue to educate banks and meet with relevant Government agencies to keep the pressure on to make Sector inclusive decisions. We remain cautiously optimistic and committed to these ongoing conversations. We continue to monitor the effects of DIA umbrellaing the active arm of the AML/CFT (Anti Money Laundering and the Countering of Financing of Terrorism) legislation.

CNA remains on the CBDC Forum (Central Bank Digital Currency), though progress has slowed due to a different approach and while the onboarding of the new Governor Dr. Anna Breman occurs.

First Credit Union still maintains its boutique Not for Profit banking option.

Sector Resource: WiseComply

Mid-2025 saw us teaming up with WiseComply to beta-test an app that would enable small organisations to remain compliant as our Sector becomes harder to navigate continuing re-legislation.

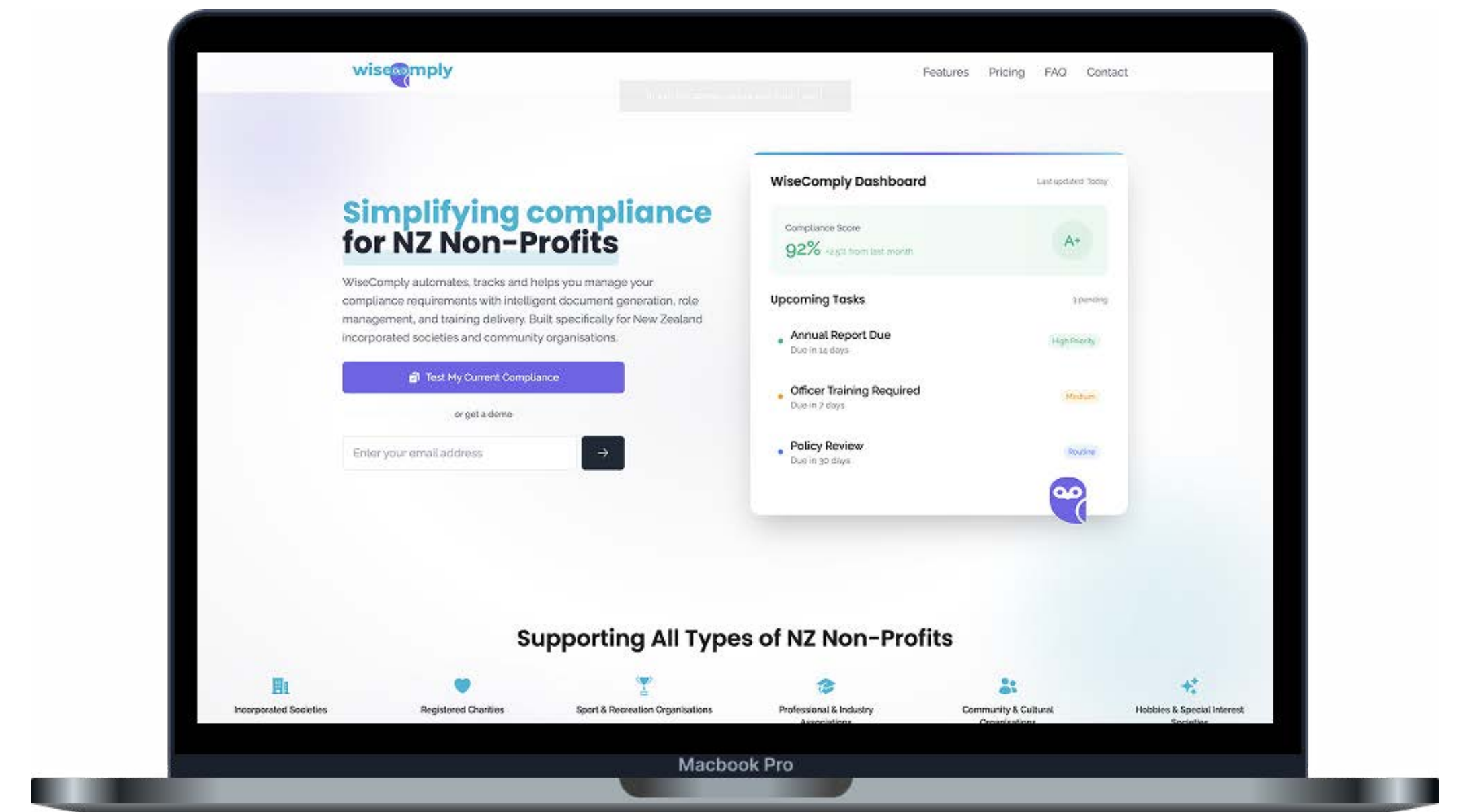
WiseComply is the brainchild of Eugene Cash and Sarah Sinclair who recognised the difficulty of incorporated societies re-registering by April 2026 to remain in-line with the Incorporated Societies Act 2022.

Accessed online, each organisation can securely upload their information. Looking at documents, public information, and legislation, WiseComply creates a plan of action – when to do what, and reminders – to keep you compliant with legislation and all your important dates in your calendar.

CNA acquired funding to allow 60 organisations of varying types to secure a license and to ensure the app is fit for purpose. We began our first tranche of tester in November and will continue in 2026.

We strive to ease pain points for small, community organisations in an increasingly compliance heavy sector – we feel WiseComply will be advantageous to NFPs.

CNA Financial Report 2025:

CNA completed our fiscal year 2024-25 in a good position to continue delivering on our priorities. The year ended with a modest deficit of \$36,385 which is an improvement from the prior year. Annual revenue was \$386,895 and total expenses were \$423,280. This result was forecast, and the Executive Committee and staff continue to work on increasing our revenue to match the needs of our members. As staffing makes up around two-thirds of our expenses, we are committed to focus on growing our capabilities rather than trimming during a time of increased complexity and need for our leadership.

We can make this decision based on the prudent oversight of our financials over many years resulting in accumulated funds of \$350,976 at year end. Support from the Ministry of Social Development is appreciated and represents the majority of our revenue. This year we also received \$15,000 from the JR McKenzie Trust and the same from Lottery Grants Board. We are slowly growing our earned income and relationships with values aligned funders to ensure our sustainability through changing fiscal cycles.

On behalf of the Executive Committee, I express our thanks to the solid work of staff and our accountant Christine Young. You can review the full results in the Statement of Service Performance and letter from the review;
