Board definition of Regular Member in Good Standing

May 17, 2023

1. A person who graduated from St. Louis School in the class of 1972 and before, who is currently on the SLAA roster of Regular Members, is a Regular Member in good standing and remains a Regular Member in good standing under Resolution No. 04.19.23 RE: 50th Anniversary Regular Members (because that person has been grandfathered in).
2. A person who graduated from St. Louis School in the class of 1973, who is currently on the SLAA roster of Regular Members is a Regular Member in good standing (i.e., he paid his \$20 annual fees for a least part of the year immediately preceding the 50th anniversary of his graduation date) and will be entitled to pay \$0 as his annual dues to the extent that annual dues are due and payable after the 50th anniversary of his graduation date.
3. If a person is approaching the 50th anniversary of his graduation date in 2023 (or beyond) and he was not a "dues paying" Regular Member for at least part of the year immediately preceding the 50th anniversary of his graduation date, he will need to pay the \$20 annual dues on or before June 1st to be a Regular Member in good standing as of the 50th anniversary of his graduation date and be eligible for the \$0 dues category thereafter.
4. If a person has passed the 50th anniversary of his graduation date and he (a) was never a dues paying Regular Member before that date, or (b) was not a dues paying member for at least part of the year immediately preceding the 50th anniversary of his graduation date, he will need to pay the \$20 annual dues the year that he joins the SLAA or rejoins the SLAA as a Regular Member. The year after that, the person would be eligible to pay the \$0 annual fees because he would have been a Regular Member in good standing for a year and, thereafter, would in fall in the category of a Regular Member in good standing who has passed the 50th anniversary of his graduation.
