(b) The township owner has submitted sufficient guarantees and cash contributions in respect of the provision of services for the ERVEN and/or paid to the Municipality.

Since the township Derdepoort Extension 5 was submitted prior 1 July 2015 neither the Spatial Planning and Land Use Management Act 16 of 2013 (SPLUMA), nor the Tshwane Land Use Management By-Law 2016, are applicable on this township.
