TRAINING APPROACHES

- BOTH ARC AND HSI UTILIZE HANDS-ON PRACTICE, MULTIMEDIA PRESENTATIONS, VIDEOS, AND INTERACTIVE RESOURCES TO DELIVER EFFECTIVE CPR TRAINING. BOTH OFFER ALMOST IDENTICAL LENGTH CLASSES DEPENDING ON THE CLASS TYPE YOU CHOOSE. HSI IS OFTEN MORE FLEXIBLE REGARDING TRADITIONAL CLASSROOM TRAININGS TO MEET CLIENT NEEDS. HSI FIRST AID CLASSES STILL INCLUDES BASIC FIRST AID WHILE RED CROSS ONLY COVERS LIFE-THREATENING EMERGENCIES. HSI INCLUDES EPI-PEN, OPIOID OVERDOSES, PLUS OTHER ADD-ONS UPON REQUEST THAT CAN BE INCLUDED IN BASE LEVEL CPR/FIRST AID UPON REQUEST ALLOWING CUSTOM COMPONENTS & ADDITIONAL TOPICS FOR EXTREMELY AFFORDABLE COSTS SPECIFIC TO YOUR COMPANY NEEDS WHILE ARC REQUIRES EACH INDIVIDUAL ADD-ON TO BE ISSUED AS A SEPARATE CERTIFICATION.

CERTIFICATION DURATION

- THE BASE LEVEL CERTIFICATIONS FROM BOTH ARC AND HSI ARE VALID FOR TWO YEARS. CLASSES ARE ALMOST IDENTICAL IN LENGTH. HSI IS OFTEN SLIGHTLY LONGER AS THEIR CLASSES GO MORE IN DEPTH AND INCLUDE MORE REAL LIFE SCENARIOS THAN RED CROSS.

CERTIFICATION RECOGNITION

- THE CPR CERTIFICATIONS FROM ARC AND HSI ARE BOTH WIDELY ACCEPTED AND MEET OSHA WORKPLACE GUIDELINES FOR CPR/AED TRAINING. HOWEVER, THE LEVEL OF RECOGNITION MAY VARY BASED ON SPECIFIC NEEDS AND REGIONAL PREFERENCES. PLEASE CHECK WITH YOUR ORGANIZATION IF UNSURE.

TRAINING COSTS

- THE COSTS OF ARC AND HSI CPR COURSES DIFFER BASED ON FACTORS LIKE THE COURSE TYPE, LOCATION, AND ADDITIONAL MATERIALS OR CERTIFICATIONS PROVIDED. TYPICALLY HSI IS \$10-30 LESS PER PARTICIPANT THAN ARC.

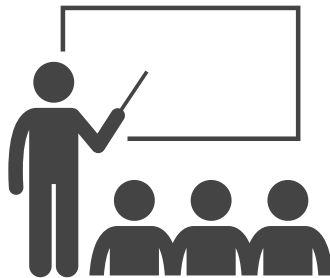

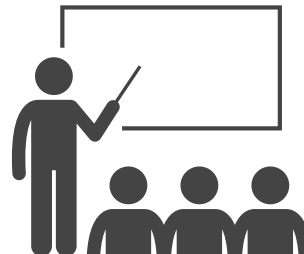

INSTRUCTOR LEVEL MENTORSHIP

It takes more than just completing an instructor-level class to be a high-quality instructor. While your job may not require this, those who want more than just a one day course to become a high quality instructor have the option to add on mentorship. Learn how to teach in a variety of methods, learn the in & outs of equipment, running classes live, and gaining confidence one step at a time with an experienced instructor. It costs \$100 to complete the mentorship, and must be completed within 1 year of starting mentorship. No prior experience other than holding a base level CPR/AED/FA certification is necessary. Just a willing to learn attitude, strong work ethic, a desire to impact the community and a positive mindset is required to be accepted.

Mentorship Requirement:

1. Shadow/teach 4 - 6 CPR, AED & First Aid Limitless Training Classes (at least 2 Blended & 2 Traditional Classroom)
2. Begin to teach 1 module at a time adding an additional module per class you attend with Jess after shadowing/attending your first class.
3. Complete 2 mentorship planning meetings with Jess (Can be via zoom/phone).
4. Teach a full class OR pass the instructor level course.

*This could take 2-16 weeks depending on how available you are to attend classes.
You must contact Jess directly for class locations and info to shadow at least 48 hours prior to attending.*

Once you pass the mentorship AND instructor level course, you will be given the option to align with Limitless Training as a Training Center where you can run your own courses, teach with Limitless Training as a Contractor, or start your own LLC to run an independent Training Center/align with another already existing. You will also be given the purchase manikins from Limitless Training after completing your instructor level course.

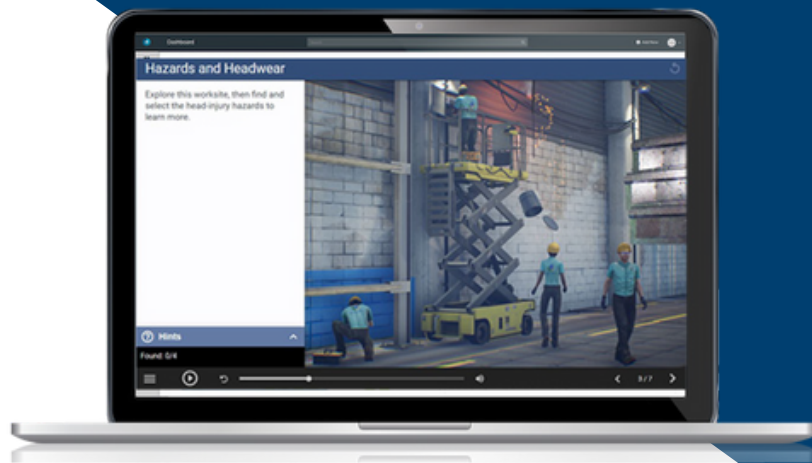
