1. Information We Collect

We may collect the following types of information when you use our Site:

a. Personal Information

- Name, email address, phone number, mailing address.
- Payment or billing details when making a donation.
- Account login information if you register for certain features.

b. Non-Personal Information

- IP address, browser type, device type, operating system.
- Pages viewed, time spent, and referring website.
- General geographic location (city, state, country).

c. Cookies and Tracking Technologies

We use cookies, analytics tools, and similar technologies to enhance your browsing experience, improve performance, and analyze Site usage. You may disable cookies in your browser settings, but some features may not function properly.

2. How We Use Your Information

We may use your information to:

- Provide access to Site features and resources.
- Process and confirm donations.
- Communicate updates, newsletters, devotionals, and ministry opportunities.

- Improve Site performance, design, and content.
- Ensure security and prevent fraud.
- Comply with legal and regulatory requirements.

3. Sharing of Information

We do not sell, rent, or trade your personal information. We may share your data with:

- **Service Providers:** Third-party vendors who process donations, manage email lists, or provide hosting and security.
- **Legal Compliance:** When required by law, regulation, or court order.
- **Ministry Operations:** Within His Vision Ministries staff and trusted partners, solely for ministry purposes.

4. Donations

When making a donation, payment information is processed securely by third-party payment processors. We do not store your full credit card details. Donation records may be maintained for accounting and compliance purposes.

5. Your Choices

You have the right to:

- Opt out of marketing emails at any time by clicking “unsubscribe.”
- Request access to, correction of, or deletion of your personal information.
- Restrict certain processing of your data, where applicable under law.
