# Who Can Apply?



1. Public Housing Authorities, units of local government or nonprofit organizations
2. Must manage properties serving residents that receive housing assistance from a local, state or federal program.

Ex. Subsidized housing assistance programs, Transitional housing programs, senior living facilities, group homes and other community-based supportive housing.

# Energy Efficiency Assessment Program



Funds will be awarded to residential properties serving populations receiving housing assistance



Available to ALL utility service areas.



Awards range from \$5,000 to \$60,000



Eligible to apply for funding to make recommended upgrades through the Energy Efficiency Trust Fund Grant Program upon completion of assessment.

## What is an Energy Efficiency Assessment/Audit ?

- A written evaluation of a property's structure, equipment and behavior conducted by a third-party professional with the goal of reducing energy costs and increasing building performance.





# Energy Efficiency Assessment - Eligibility

Criteria	Yes	No
1. Is the property or are the properties to be assessed located in Illinois?		
2. Is the property managed by a public housing authority, municipality, county, township, or nonprofit organization?		
3. Is the property primarily used for residential purposes?		
4. Do property residents benefit from federal, state or local public housing programs, housing choice vouchers, rental assistance, or subsidized housing?		
5. Is the applicant property unable to receive a free energy efficiency assessment from the local utility service provider?		
6. Can the applicant provide detailed invoices for eligible costs and submit to Illinois EPA no more frequently than monthly?		
Additional GATA Criteria	Yes	No
10. Can the applicant meet <b>all</b> of the following pre-qualification requirements through the GATA grantee portal, <a href="http://www.grants.illinois.gov">www.grants.illinois.gov</a> , at the time of award?		
11. Does applicant have a valid UEI number?		
12. Does applicant have a current SAM.gov account?		
13. Can the applicant prove it is not on the Federal Excluded Parties List?		
14. Is the applicant in good standing with the Illinois Secretary of State?		
15. Can the applicant prove it is not on the Illinois Stop Payment List?		
16. Can the applicant prove it is not on the Dept. of Healthcare and Family Services Provider Sanctions List?		
17. Applicant either: (a) has a current Internal Controls Questionnaire (ICQ); OR (b) is willing to complete an ICQ before Illinois EPA issues a Notice of State Award (NOSA) resulting from this NOFO?		

# Energy Efficiency Trust Fund Grant Program



Funding for energy efficiency upgrades at single family and multifamily properties. Up to 40 dwelling units.



Upgrades must have been identified in an energy efficiency assessment conducted within the last 5 years.



Awards range from \$50,000 to \$1,000,000

# Energy Efficiency Trust Fund – Eligibility

Criteria	Yes	No
1. Is the project located in Illinois?		
2. Do property residents benefit from federal, state or local public housing programs, housing choice vouchers, rental assistance, or subsidized housing?		
3. Is the property managed by a public housing authority, municipality, county, township, or nonprofit organization?		
4. Has there been an energy efficiency assessment performed by a third-party assessor within the last five years?		
5. Did the energy efficiency assessment yield written recommendations for energy efficiency improvements?		
6. Does the proposed project only include improvements identified in the written recommendations from the energy efficiency assessment?		
7. Can the applicant provide a calculated energy cost savings (\$/kWh) for the project?		
8. Does the proposed project impact 40 or fewer dwelling units at the residential property AND improvements for health/safety or common areas represent no more than 20% of the requested award?		
9. Can all appliances, systems, equipment, and building material components meet the ENERGY STAR product criteria on the date of installation? (Note: Please indicate if ENERGY STAR product is unavailable.)		
10. Can the applicant provide detailed invoices for eligible project costs and submit to Illinois EPA no more frequently than monthly?		
11. Can the applicant meet the cost share requirement?  The cost share for selected projects is determined based on the total award request: <ul style="list-style-type: none"><li>• 2% cost share of the total award request for awards between \$100,000 to \$249,999.99;</li><li>• 5% cost share of the total award request for awards between \$250,000 to \$499,999.99; and</li><li>• 10% cost share of the total award request for awards between \$500,000 to \$1,000,000.</li></ul>		

# Program Features

- Rolling Application Period – Opens Sept 22, 2025
- ✓ Awards will be made until all funds are expended OR:
  - Energy Efficiency Assessment – Close March 31, 2026
  - Energy Efficiency Trust Fund – Close June 30, 2026.
- Non-Competitive Program – First Come, First Served
- Payment is remitted to the **Grantee** based on detailed invoices of costs to be incurred. Grantee provides proof of payment to contractor no later than 45 days after receipt of funds from IEPA.

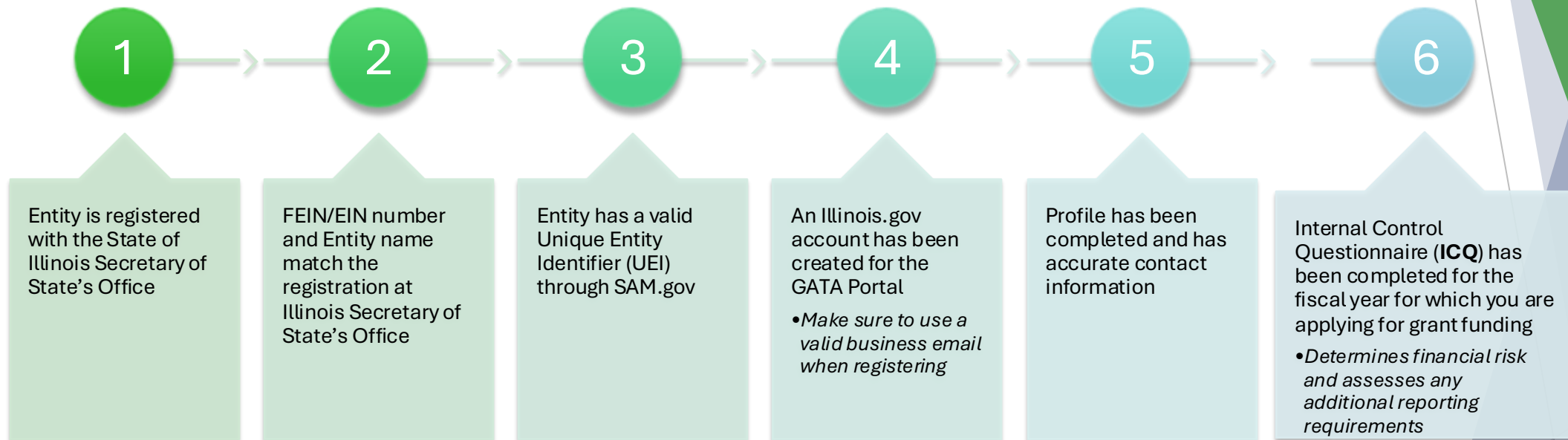

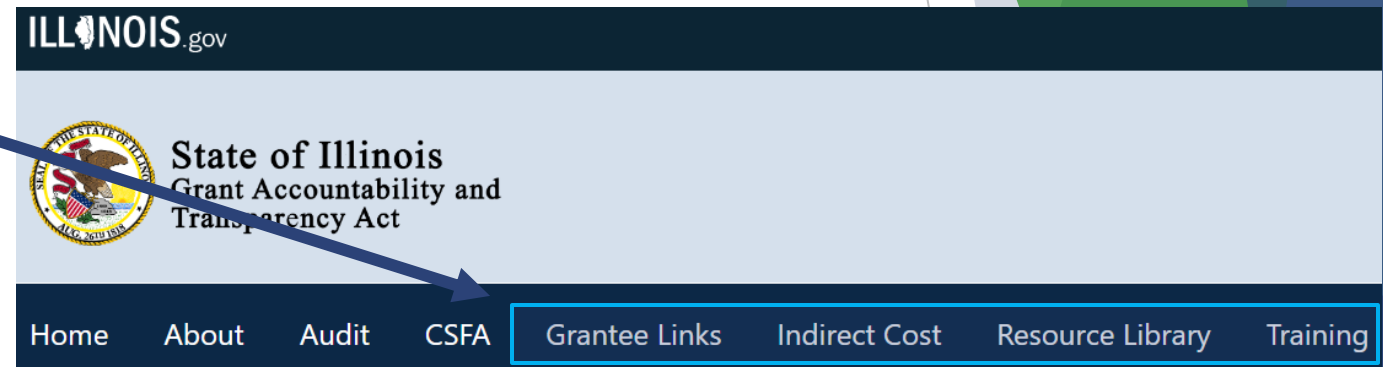

## EEA Components

- ▶ 1. Cover Letter – Impact of assessment on property management
- ▶ 2. Narrative Project Plan
- ▶ 3. Project Timeline - Projects impacting multiple properties should have milestones for EACH property.
- ▶ 4. Budget
- ▶ Required Forms

## EETF Components

- ▶ Cover Letter – Briefly describe your organization, the project property and how this project will impact residents receiving housing assistance.
- ▶ Narrative Project Plan
- ▶ Project Timeline – Projects impacting multiple properties should have milestones for EACH property.
- ▶ Budget
- ▶ Energy Efficiency Assessment
- ▶ Required Forms
