MINUTES OF REGULAR MEETING

NOVEMBER 20, 2025

THE FRIOT COUNTY EMERGENCY SERVICE DISTRICT NO. 1 COMMISSIONERS CONDUCTED A REGULAR MEETING ON NOVEMBER 20, 2025 AT 7:00 P.M. AT THE PEARSALL VOLUNTEER FIRE DEPARTMENT LOCATED AT 320 S OAK ST, PEARSALL, TEXAS 78061.

**Call the Frio County Emergency Service District No. 1 (“ESD”) Board Meeting to Order; Secretary will call roll; Quorum is established, Invocation and Pledge of Allegiance.** Chico Hines called the meeting to order at 7:01 pm. Chico Hines, Royce Starnes and JD Earls were present. Bob Grubb was absent. A quorum was established. Chico Hines gave the invocation and led the pledge of allegiance. Linda Parsons joined the meeting at 7:03 pm.

- 1) **Citizens to be heard.** No citizens requested to be heard.
- 2) **Approval of minutes.** JD Earls made a motion to approve the minutes of the October 16 meeting. Royce Starnes seconded the motion, with all in favor, the motion passed.
- 3) **Approval to pay bills and treasurer’s report.** Royce Starnes gave the treasurer’s report and made a motion to pay the bills presented and accept the treasurer’s report. Linda Parsons seconded the motion, with all in favor, the motion passed.
- 4) The next meeting is scheduled for December 4, 2025 at Pearsall VFD.
- 5) **Discussion, consideration, possible action and any issues relating to the report from Texas ESD Consulting.** No action was taken.
- 6) **Discussion, consideration, possible action regarding presentation of records management system.** Jay Gruen gave an update; no action was taken.
- 7) **Discussion, consideration, possible action regarding service provider agreements for the next fiscal year.** Item was discussed in Executive Session.
- 8) **Discussion, consideration regarding update from Moore VFD on progress of current audit.** Item was discussed in Executive Session.
- 9) **Discussion, consideration, possible action regarding a request by Moore VFD to approve donation of expired PPE.** Linda Parsons made a motion to allow Moore VFD to donate the listed items and furnish acknowledgement of receipt of the items. Royce Starnes seconded the motion, with all in favor, the motion passed.
- 10) **Discussion regarding a request by Moore VFD to fund a training event.** Chief Hitchcock requested ESD funding for nine Moore VFD firefighters to participate in a TCFP class with the ESD funding to be reimbursed after course completion with grant funds. He will provide an invoice for the class at the December meeting.

Royce Starnes made a motion to table this item until a future date. Linda Parsons seconded the motion, with all in favor, the motion passed.
- 12) **Discussion, consideration, possible action regarding the next 2024 VFD audit.** Linda Parsons made a motion to audit Bigfoot VFD next. Royce Starnes seconded the motion, with all in favor, the motion passed.

Royce Starnes made a motion to request the attorney and Denise Woody to follow up on item discussed in Executive Session in regards to research. Linda Parsons seconded the motion. The motion passed with Chico Hines, Royce Starnes and Linda Parsons voting in favor. JD Earls abstained.
