1. **SPONSOR'S PRECONTRACT DUTIES:**

- a. SCA's Contingent Prize Contract and Exhibit A – Terms & Conditions, signed and returned to SCA; and
- b. Payment of Contract Fee to SCA.

2. **SPONSOR'S OBLIGATIONS AND SCA'S REQUIREMENTS FOR PRIZE PAYMENT:**

a. **DEFINITIONS:**

- i. **"Eligible Location"** shall mean those waters off the Gulf of Mexico eligible for the State of Louisiana record consideration; and
- ii. **"Eligible Species"** shall refer to Jack Crevalle, Black Drum, Gafftopsail Catfish, Cobia, Tarpon, and Broadbill Swordfish as recognized by the IGFA; and
- iii. **"IGFA"** shall mean the International Game Fishing Association; and
- iv. **"Tournament"** shall mean the Golden Meadow Fourchon Tarpon Rodeo to be held from July 4, 2025 through July 6, 2025, and in which no more than one thousand (1,000) anglers may participate; and
- v. **"Tournament Participant"** shall mean a person officially entered in the Tournament.

b. If:

- i. an Eligible Species is caught by a Tournament Participant during the Tournament dates and times in accordance with all state, federal rules and IGFA; and if
- ii. the largest Eligible Species caught during the Tournament establishes a new "All Tackle Louisiana State Record", as certified by the applicable governing bodies that establish and certify said record; and if
- iii. Sponsor and Tournament Participant have complied with the terms and conditions of this contract and Sponsor's Official Promotion Rules then SCA will pay Sponsor the prize amount scheduled in the Schedule of Available Prizes below, subject to the Maximum Aggregate Liability and verification by SCA.

- c. In order to be eligible for a prize, an **"All Tackle Louisiana State Record"** fish must be caught in the manner prescribed by the IGFA international angling rules. Any variance in this condition must be with the express **written** consent of SCA prior to the start of the Promotion.

- d. All Tournament waters (i.e., the Eligible Location) must have been open to the public for fishing for at least one (1) year immediately prior to the Promotion, and must have an existing certified Louisiana state record for the Eligible Species recognized by the appropriate state record keeping authority for the Eligible Species.

e. **Requisite Qualifications for Prize Award:**

- i. An Eligible Species must be eligible for and establish a new **official All-Tackle Louisiana State Record** weight for the specified species.
- ii. An Eligible Species must be caught by a Tournament Participant during the Tournament dates and times.
- iii. An Eligible Species must **ultimately** be **certified** as the **official Record for the Eligible Species**, and SCA must receive verification of said verification from the **Louisiana state record keeping authority**.
- iv. All certification requirements will be the exclusive responsibility of the claimant, and must be completed within a reasonable period of time, but not to exceed ninety (90) days unless agreed to in writing by SCA.
- v. If there is a potential winner, Exhibit B must be completed in its entirety and mailed in a timely manner to SCA, but not to exceed sixty (60) days unless agreed to in writing by SCA Promotions.
- vi. Any winner, regardless of issue, must submit to and pass, in a conclusive manner, a polygraph examination administered by a licensed polygraphist provided by the contract sponsor as a condition precedent to prize payment consideration.

- f. **Eligible Tournament Participants:** Only those Tournament Participants officially entered in the Tournament who comply with the terms and conditions of this Contract and Sponsor's Official Promotion Rules shall be eligible to compete for a prize. **In the event of a potential winner, Sponsor may be required to provide SCA with an official list of registered Tournament Participants in the Tournament. SCA will cover the first 1,000 Tournament Participants plus 10% overage at no additional charge to the Sponsor.**

- g. After receipt of completed and signed claim documentation, SCA or an SCA-designated independent judging organization may conduct an investigation including, but not limited to, requiring the Sponsor to provide access to the winner, witness(es), and/or contest officials to submit to and pass in a conclusive manner polygraph examinations as a condition precedent to claim consideration if, in SCA's sole opinion, such action is warranted. If required, all polygraph exams must be submitted to SCA within sixty (60) days of the conclusion of the Tournament or the claim for prize payment under this contract is void.

- h. **Force Majeure:** If the Tournament is canceled due to a force majeure preventing the conducting of the Tournament, assuming no attempts to win the prize were initiated, this contract will be amended to a rescheduled date without additional charges. Notification to SCA is required in writing within seventy-two (72) hours of official declaration of cancellation for refund consideration. Any rescheduled Tournament must be rescheduled to take place within ninety (90) days of original Tournament commencement date.

- i. Failure to comply with or disregard of any of the terms and conditions of this contract shall relieve SCA of any and all liability hereunder.
