Candidates are required to file a Declaration of Candidacy specifying the office sought and affirming that the individual is a qualified elector, meaning: at least 18 years of age, a U.S. Citizen, the candidate's primary residence must be within the District, the address of the candidate's voter registration must match the residence address provided on the candidate's declaration, and the candidate must have resided in the district for at least 30 days prior to submitting their declaration. The Declaration of Candidacy must be accompanied by a Petition of Candidacy signed by at least five qualified electors within the district and must be verified by the Franklin County Clerk's Office. The deadline for filing the Declaration of Candidacy is between Monday, August 18 and Friday, August 29 at 5:00 p.m. The Election will be held 8 AM to 8 PM on November 4, 2025. Individuals who run as write-in candidates must file their declaration of intent by September 5, 2025, no later than 5 PM.
