

Terms and Conditions

Welcome to the Rules and Regulations page for the Bay Roofing and Exteriors Ltd. Roof Giveaway. Before entering, we encourage all participants to carefully review the following terms. These guidelines are designed to ensure clarity, transparency, and fairness throughout the giveaway process.

This promotion is conducted as a random draw and is intended to provide eligible homeowners with an opportunity to win a roof replacement. By participating, you agree to comply with these rules, which help ensure the giveaway is administered smoothly and fairly for all entrants.

Bay Roofing and Exteriors Ltd will award one (1) prize at the end of the prize period. The prize period ends on June 1, 2026 at 12:00pm. The decision for the prize will be held on June 30th, 2026. Prize winner will be randomly selected by our team. All decisions are final. The odds of winning the prize are determined by the number of entries received prior to the time of the prize drawing. The winner will be notified by phone and/or email within 15 days of the drawing. Prior to awarding any prize or prize eligibility requirements of the Giveaway, Bay Roofing and Exteriors Ltd in its sole discretion, may require verification of Giveaway winners identification by a showing of valid government issued photo ID. The inability to contact the winner with the prize notification will result in disqualification and selection of an alternate winner. The selected winner must execute and return any required Affidavit of Eligibility and Release, including the skill-testing question and publicity release, within ten (10) days of the initial notification attempt.
