However, any funeral service you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.”

Basic Services of Funeral Director and Staff **\$1,495.00**

Our fee for the basic services of the funeral director and staff include conducting the arrangement conference, planning the funeral, obtaining the necessary permits, and placing obituary notices. Also included is the recording of vital statistics, overhead expenses relative to our facility such as insurance, maintenance and utility cost. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Transfer of Remains to the Funeral Home **\$395.00**

Includes 24-hour availability of personnel.

Embalming **\$560.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Other Preparation of the Body **\$255.00**

Includes cosmetizing and placement of the deceased in casket.

Facilities and/or Staff for Visitation **\$395.00**

Per day or part thereof. Includes arranging and supervision of visitation, handling and care of floral pieces, staff and/or equipment for visitation.

Funeral Ceremony **\$595.00**

Includes use of our chapel, equipment and supervision by funeral director and staff at the funeral home or church. If the ceremony is held away from the funeral home, the credit for some non-use of our facilities is used to off-set additional personnel, and transportation cost arising from the service being held away from our facility.

Direct Cremation - No Service

\$1,695.00 to \$7,190.00

Our charge for a direct cremation (without service) includes basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations and cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering.) The containers we provide are a fiberboard container.
