The provider of funeral services is prohibited from representing that the deterioration of human remains can be prevented for more than a limited time by embalming, caskets, vaults, or outer interment receptacles.

We do not perform and/or offer cremation services; you will not find that information on our price list.

Our fee for the basic services, including the funeral director and staff, includes conducting the arrangement conference, planning the funeral, obtaining necessary permits, and placing obituary notices. FORWARDING REMAINS TO ANOTHER FUNERAL HOME \$3000.00

This charge includes the transfer of the remains to the funeral director and staff services, securing necessary authorizations and local transportation to point of shipment. The charge does not include shipping charges of additional items of services, merchandise, facility use, and livery that the customer may wish to select. Transportation beyond the local point of shipment will be billed either as livery or common carrier, charges depending upon the forwarding location. Local point of shipment is up to or within 20 miles.

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME \$3000.00

This charge includes basic local transportation of the remains to the funeral home and/or place of local disposition, funeral director and staff services, and securing necessary authorizations. The charge does not include additional items of service, merchandise, facility use, and livery that the customer may wish to Transportation beyond local point of disposition will be billed as livery charges. The local place of disposition is up to or within 20 miles.
