

TERMS & CONDITIONS

01

PAYMENT

Payment is due within 15 days of execution of this agreement. Payments may be made by check or wire transfer to Jackson Hole Therapeutic Riding.

MARKETING MATERIALS

TAX DEDUCTIBILITY

JHTR will provide an official tax acknowledgment letter. Sponsorship contributions are tax-deductible to the extent permitted by law.

SPONSORSHIP GUIDELINES

CANCELLATION

If the event is cancelled or significantly altered due to circumstances beyond the control of JHTR—including but not limited to weather, natural disasters, public safety concerns, or other unforeseen events—the Sponsor may choose to receive a refund of their sponsorship payment, less the value of any sponsorship benefits already received, or convert the sponsorship into a 100% tax-deductible contribution to JHTR. If promotional or marketing benefits have already been delivered, JHTR may deduct the reasonable value of those benefits from any refund.
