Ladies and Gentlemen,

- 5. First of all, <u>I must congratulate MPC for their</u>
 <u>initiative</u> in organising this important <u>National</u>
 <u>Conference on Behavioural Insights 2022.</u>
- 6. I am confident that, from this conference, we will learn much about Behavioural Insights approach and, most importantly, obtain invaluable insights into

how policy makers applied Behavioural Insights to shape intended policy outcomes.

- 7. Our Prime Minister, YAB Dato' Seri Anwar Ibrahim, had emphasized that civil servants must uphold the reformative spirit in order to bring about changes for a better Malaysia.
- 8. In line with this, our newly formed Federal Government leadership is expected to unveil and drive a reform agenda against the backdrop of global challenges post COVID-19 pandemic and international tensions and conflicts that are impeding trade and socio-economic progress.
- 9. Notwithstanding the global situation, we know that the rakyat expects the Civil Service to formulate and the beneficial to all citizens in their work and day-to-day living.

- 10. The rakyat, be it businesses, families, or individuals, should not be burdened with policies that are cumbersome or too costly for them to comply with. Non-compliable policies are inherently self-defeating.
- 11. Certain governmental policies, however, do not achieve or only partially achieve their targeted outcomes. A common reason for the shortfall can be due to the lack of provisional understanding, prior to the implementation of policies, on how the rakyat will behave in response to implemented policies.
- 12. In seeking to change people's behaviours, first and foremost, we must try to understand why people are behaving in a certain way. This prerequisite is critical when policies are being designed or modified.
- 13. Being able to predict how people will behave, when the Government implements a policy, through the

use of Behavioural Insights to test-out proposed policies before implementation will help provide economically efficient public services to the rakyat with greater positive impact and less wastage of resources and time.

14. Behavioural Insights calls for <u>a new mindset</u> and <u>a</u> <u>new set of skills</u> in public policy making.

Ladies and Gentlemen,

- 15. Malaysia's next stage of national socio-economic transformation and progress will depend greatly on efficiency, productivity and technological advancement. Behavioural Insights-based public polices will drive towards transformation and progress.
- 16. Behavioural Insights is applicable in a very wide range of fields wherever changes in behaviours are sought for such as healthcare, education, industries, urban traffic management, transportation, natural resources sustainability and the environment.

- 17. The Twelfth Malaysia Plan 2021-2025 (RMKe-12)

 has highlighted Behavioural Insights as a

 complementary tool to be applied so as to have

 more effective public policy formulation,

 implementation and review.
- 18. Underlining the great importance placed on it by the Government of Malaysia, Behavioural Insights is embedded in the National Policy for Good Regulatory Practice (NPGRP) 2021 that encourages regulators to use Behavioural Insights as a tool to facilitate the development, evaluation, and iteration of policy options.

Ladies and Gentlemen,

19. Once again, I am very pleased to be here with all of you in this conference and I urge you to give your full support to MPC in realising Behavioural Insights initiatives. Each ministry should

- <u>champion Behavioural Insights (BI) initiatives</u> <u>through "1Ministry, 1BI Project".</u>
- 20. All civil servants both at the federal as well as the state levels should understand the need for Behavioural Insights. The time to start learning this science is now.
- 21. Our conference held today is highly significant and a meaningful milestone in the never-ending journey of the Civil Service to have the Public Sector working together closely with the Private Sector for a better Malaysia.
