МТА	Means-Test Amount	Assessable income and assets are used in a combined formula to produce a means-test amount (MTA). This is the measurement of client affordability to contribute to certain fees. If the MTA is below the MAS, the resident is considered 'low-means'.
MAS	Maximum Accommodation Supplement	The maximum daily amount that an aged care service provider can receive for accommodation for a low-means resident. Payment is split between the government and the resident. The provider may receive a lower amount if they do not qualify as new/refurbished and/or the percentage of low-means residents is 40% or less.
MPIR	Maximum Permissible Interest Rat	The interest rate used to calculate the DAP or to convert a DAC into a RAC. It is set by the government each quarter and is fixed for the client as at the date of entry, unless moving to new care service (or voluntary room move for a market
MTF	Means Tested Fee	The amount a permanent resident may be required to pay towards the cost of their care. It is based on their financial means as determined by the MTA less the MAS. Applies to residents who entered care before 1 November 2025 or after this date but qualify for grandfathering. Paid instead of the HC and NCCC
NCCC	Non-Clinical Care Contribution	The amount a permanent resident may be required to pay towards their cost of care. It is based on their financial means as determined by the MTA less MAS less maximum HS. Applies to residents who enter care from 1 November 2025 and not under grandfathering rules or those who moved in before that date but opt into the new rules. Paid instead of MTF.
RAC	Refundable Accommodation Contribution	The lump sum that can be paid by a low-means resident towards their cost of accommodation. Calculated as the DAC multiplied by 365 days then divided by MPIR.
RAD	Refundable Accommodation Deposit	The lump sum amount that is agreed as the cost of accommodation in a residential care service (not low-means). It is the advertised price on the My Aged Care website
SA	Services Australia	The Government agency which is responsible for the delivery of government.
SAH	Support at Home	Program that provides support to older people to enable them to remain living at home. Support provided through a range of funding packages to assist with the costs of accessing care at home. Replaced the Home Care Package program from 1 November 2025.
SAS	Single Assessment System	System that arranges and conducts an older person's aged care needs assessment to eligibility for government-funded aged care services and grant approval. both at home and in a residential environment. It applied to combine the RAS and ACAT/ACAS assessments into one aged care needs assessment process from December 2024.
