#### ○ **About the Notice**

This Privacy Information explains how we use your personal data: how it is collected, how it is held, and how it is processed. It also explains your rights under the law relating to your personal data.

#### ○ **Defining Personal Data**

Personal data is information that relates to an identified or identifiable individual. An individual is 'identified' or 'identifiable' if you can distinguish them from other individuals. Common means of identifying someone may include, for example:

- ❖ Name
- ❖ Date of birth
- ❖ Identification numbers
- ❖ Bank details
- ❖ Addresses, including email addresses
- ❖ Other location data, such as an IP address
- ❖ Online identifiers

#### ○ **Explaining Your Rights**

The UK GDPR provides the following rights for individuals:

- ❖ The right to be informed
- ❖ The right of access
- ❖ The right to rectification
- ❖ The right to erasure
- ❖ The right to restrict processing
- ❖ The right to data portability
- ❖ The right to object

If you have any cause for complaint about our use of your personal data, you have the right to lodge a complaint with the Information Commissioner's Office.

We may collect some or all of the following personal data:

- ❖ Telephone number

## **How Personal Data is Used at Sporttiers?**

Under the GDPR, we must always have a lawful basis for using personal data. This may be because the data is necessary for our performance of a contract with you, because you have consented to our use of your personal data. Your personal data may be used for one of the following purposes:

- ❖ Setting up and managing your Membership
- ❖ Supplying our products or services to you.
- ❖ Personalising and tailoring our products and/or services for you.
- ❖ Communicating with you, via calls, emails, WhatsApp, social media etc.

### **○ Length of which Sporttiers Keeps Data**

We will not keep your personal data for any longer than is necessary. Your personal data will therefore be kept for the duration of our agreement with you and for one year following the termination of our agreement for Auditing purposes.

### **○ How and Where Do You Store or Transfer My Personal Data?**

We will only store your personal data in the UK. This means that it will be fully protected under the GDPR, and use a trusted payment & collection service [London & Zurich] to ensure Sporttiers do not hold bank details and other personal data within company documents.

### **○ Do We Share Your Personal Data?**

If any of your personal data is required by a third party, we will take steps to ensure that your personal data is handled safely, securely, and in accordance with your rights, our obligations, and the third party's obligations under the law.

In some limited circumstances, we may be legally required to share certain personal data, which might include yours, if we are involved in legal proceedings or complying with legal obligations, a court order, or any issues with children's safeguarding.

### **○ Changes to Personal Data**

Any changes to data made by customers should be flagged with Sporttiers Directors to ensure up-to-date information is available. Any old data will be removed by Sporttiers, and not stored.
